Realignment of Permit Parking Area 9A to exclude the development located at 276-294 Main Street and 144 Stephenson Avenue

SUMMARY

Transportation Services is requesting approval from City Council to prohibit the General Manager from accepting applications from residents of, visitors to, and tradespersons at the development property municipally known as 276-294 Main Street and 144 Stephenson Avenue for residential on-street permit parking.

Transportation Services has assessed the realignment of permit parking area 9A and the exclusion of the development property located at 276-294 Main Street and 144 Stephenson Avenue as requested by Toronto and East York Community Council, Item TE3.9, on February 26, 2019. Transportation Services is recommending approval of the exclusion as it will not impact negatively on Main Street and Stephenson Avenue residents.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, Transportation Services recommends that:

1. City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "9A", as attached in Appendix A of the report dated November 6, 2019 from the Manager, Permits and Enforcement, Parking, Transportation Services.

FINANCIAL IMPACT

The amount of \$100 is available within the Transportation Services 2019 Operating Budget.

DECISION HISTORY

At its meeting February 26, 2019 Toronto and East York Community Council in considering item TE3.9, requested Transportation Services to examine and report back to Toronto and East York Community Council regarding the realignment of permit parking area 9A to exclude the development at 276-294 Main Street and 144 Stephenson Avenue.

COMMENTS

Permit Parking area 9A is bounded by Coxwell Avenue on the west, the former East York boundary to the north, Victoria Park Avenue to the east and the CN Railway to the south. Area 9A has 2,208 on-street parking spaces. To date, 1,843 permits have been issued. This area does have a history of being waitlisted, meaning the demand for overnight on-street parking permits has exceeded the supply of parking spaces. There is TTC service Main Street and no TTC service on Stephenson Avenue.

Transportation Services has no objections to the exclusion of the development located at 276-297 Main Street and 144 Stephenson Avenue from permit parking area 9A.


