## Amendment of Designating By-law to Correct Legal Description - 440 Unwin Avenue

#### SUMMARY

This report recommends that City Council state its intention to amend City of Toronto By-law 1144-2019 designating the property at 440 Unwin Avenue under Part IV, Section 29 of the Ontario Heritage Act to correct the legal description.

By-Law 1144-2019 designating the property at 440 Unwin Avenue, which contains the Richard L. Hearn Generating Station, included an incorrect legal description. The proposed Amendment to the by-law would correct the legal description. This will have no impact on the Statement of Significance (Reasons for Designation) in the original report to City Council recommending the property's designation.

#### RECOMMENDATIONS

1. City Council state its intention to amend By-law 1144-2019, dated July 26, 2019, to correct the legal description.

#### FINANCIAL IMPACT

There are no financial implications from the adoption of this report.

#### **DECISION HISTORY**

#### **COMMENTS**

No objections to the designation were received.

Following the passing of the By-Law 1144-2019 on July 26, 2019 it was noted that the legal description in the by-law was incorrectly stated as "PIN 21385-0146 (LT) PART OF BLOCK G AND H, REGISTERED PLAN 675E, DESIGNATED AS PART 1 PLAN 66R-19990" in Schedule B of the By-law. The correct description is "PART OF PIN 21385-0221 (LT) PART OF BLOCK G, H AND J, REGISTERED PLAN 675E, DESIGNATED AS PARTS 52 AND 53, PLAN 66R-29705." The correct description was included in the original report, dated February 7, 2019, to the Toronto Preservation Board, Toronto and East York Community Council and City Council.
