# Proposed Increase - Parking Violation Notice Penalty Amount

Date: October 20, 2020

To: Board of Directors, Toronto Parking Authority From: Acting President, Toronto Parking Authority

#### SUMMARY

This report provides additional information regarding an increase to the off-street parking administrative penalty amounts for the 2021 Operating Budget.

Within its inventory of more than 300 off-street parking facilities, Toronto Parking Authority (TPA) has removed the daily maximum rate at 32 high demand locations. This rate structure encourages the turnover of parking, which is consistent with TPA's mandate to provide short-stay high turnover parking.

Out of the 32 carparks where the daily maximum rate has been removed, there are 17 car parks where the \$30.00 penalty amount is less than the cost to park for an eight (8)-hour period. The discrepancy between the parking rates at these 17 locations and the penalty amount has raised concern that customers are electing to park without paying for parking as the risk and cost of receiving a Parking Violation Notice (PVN) is less than the cost of parking for a full day.

To verify the extent of the compliance issues, TPA undertook surveys and found that, on average, only 64percent of vehicles were paying for parking. The full survey details can be found in Attachment 1.

As a result of the observed compliance issues, TPA is recommending an amendment to City of Toronto Municipal Code Chapter 610, *Penalties, Administration of*, to increase the penalty amount from \$30.00 to \$75.00 for vehicles parked at municipal parking facilities in violation of Sections 950-601C(1), 950-601C(2), 950-601C(3), 950-601F(1), 950-601G(1), 950-601G(2) and 950-601O of Chapter 950, Traffic and Parking.

The increased penalties are intended to promote compliance.

#### **RECOMMENDATIONS**

The Acting President, Toronto Parking Authority, recommends that:

- 1. the Board of Directors of Toronto Parking Authority refer this report to City Council for consideration through Budget Committee;
- 2. City Council increase the penalty amount from \$30.00 to \$75.00 for the offences in Sections 950-601C(1), 950-601C(2), 950-601C(3), 950-601F(1), 950-601G(2) and 950-601O of City of Toronto Municipal Code Chapter 950, Traffic and Parking, with an implementation date of June 1, 2021; and
- 3. City Council amend City of Toronto Municipal Code Chapter 610, Penalties, Administration of, generally as set out in Attachment 2 to this report from the Acting President, Toronto Parking Authority.

#### FINANCIAL IMPACT

Implementation of the new PVN penalty amount is estimated to cost \$365,000 - \$400,000, which is needed to update Toronto Police Services' (TPS) Pre-Printed Ticket Manual. TPS will be requesting quotations for the update and a more refined estimate will be available at that time. Sufficient funding is available in TPA's 2020 Capital Budget TPA908615-1 (CPK376-01) to cover these expenses.

TPA has confirmed that there are no costs associated with the implementation of the new PVN penalty amount for Technology Services, Revenue Services, Legal Services or Court Services.

TPA estimates that \$220,000 in additional revenue will be generated in 2021 at TPA offstreet facilities as a result of the increased penalty amount, which increased penalty amount is expected to improve compliance rates of paid parking. This estimate accounts for the reduced demand for parking that is expected to continue through 2021 as a result of the Covid-19 pandemic and has been accounted for in the revenue forecasts that are included in TPA's 2021 Budget submission.

It is further estimated that the PVN penalty amount increase will generate an additional \$750,000 in revenue to Parking TAGS in 2021.

#### **DECISION HISTORY**

There is no prior decision history associated with this report.

#### **COMMENTS**

The City of Toronto implemented an Administrative Penalty System (APS) for parking violations on August 28, 2017. The APS allows City Council to set the administrative penalty amount (penalty amount) for all parking violations.

Under Chapter 610 of the Municipal Code, the current penalty amount for a PVN issued at a TPA off-street parking facility is \$30.00.

A number of factors may be considered when reviewing penalty amounts for parking violations. These include the impact of non-compliance, comparable violations, and penalty amounts in other jurisdictions.

Within its inventory of more than 300 off-street parking facilities, TPA has removed the daily maximum rate at 32 high-demand locations. This rate structure encourages the turnover of parking, which is consistent with TPA's mandate to provide short-stay high turnover parking.

A detailed review of the 17 locations where the PVN penalty amount is below the cost of parking for an eight-hour period was carried out by TPA (refer to Attachment 3). Based on the results of the surveys, it was found that only 64 percent of vehicles, on average, were paying for parking.

As an example of the discrepancy between the PVN penalty amount and parking rates in effect, Car Park 263, which is located at 130 Elizabeth Street, has a half-hour rate of \$4.00, which translates to a cost of \$64.00 to park over an eight-hour period. Where customers are parking for a period of more than four (4) hours, it is less costly to pay the penalty amount instead of the parking rates that are in effect.

Based on the analysis carried out, it has been determined that a penalty amount of \$75.00 would be needed to encourage compliance at these facilities. The proposed penalty amount of \$75.00 is consistent with the penalty amounts imposed by the City of Toronto (City) for other parking-related infractions on municipal property. Attachment 4, Table 1 includes a summary of the penalty structure applied by the Parks, Forestry & Recreation Division for unauthorized/improper parking, which is generally set at \$100.00.

The proposed penalty amount is also consistent with the fine amounts applied by other municipal parking authorities in Canada, including the cities of Montreal and Vancouver, which have minimum fines of \$78.00 and \$68.50, respectively. Attachment 4, Table 2 includes a summary of the fine structure applied by the cities of Montreal and Vancouver as well as other comparable jurisdictions.

Both the existing and proposed penalty amounts are low relative to the fine structures in place with other public agencies, including the Toronto Transit Commission, which has a fine amount of \$425.00 for passengers failing to display a valid TTC fair and Metrolinx, which has a fine amount of \$125.00 for customers parking in a reserved parking space without authorization. Attachment 4, Table 3 details these amounts.

The increased penalty amount from \$30.00 to \$75.00 will encourage compliance at TPA's off-street parking facilities and will ensure an availability of short-term high turnover parking. Should the recommendations of this report be endorsed, TPA will work to implement the increased penalty amounts by June 1, 2021.

#### ATTACHMENT 1 - COMPLIANCE SURVEY RESULTS

At the 17 car park locations that the Toronto Parking Authority (TPA) has removed the maximum day rates, it was suspected that parkers would elect to not pay for parking and instead pay the Parking Violation Notice (PVN) amount given that the penalty amount is below the cost of parking for an eight-hour period.

To confirm the extent of the suspected compliance issue, TPA undertook compliance surveys at 13 of its' off-street facilities. The surveys were carried out between July 30 and August 19, 2019 and took place in either the afternoon or late morning. Car parks were surveyed twice during this period with the exception of CP 219, which was surveyed four times.

All parked cars were classified into one of four categories: 1) having an Accessible Parking Permit; 2) having a paid ticket on display on their dashboard; 3) having either not paid or paid using the mobile GreenP app; or 4. having an infraction ticket. The license plate numbers were recorded for those who had either not paid or had used the mobile GreenP app. The list of license plates was then cross-referenced against mobile pay data to determine which cars had paid and which had not. The compliance results are summarized below in Table 1.

The overall compliance rate for the 13 car parks without a maximum day rate was found to be only 64percent with the overall range of rates falling between 43 - 78 percent.

A detailed review of the 17 locations where the penalty amount is below the cost of parking for an eight-hour period was carried out by TPA. Car Park 263, located at 130 Elizabeth Street, has a half hour rate of \$4.00, which translates to a cost of \$64.00 to park over an eight-hour period. Where customers are parking for a period of more than four (4) hours, it is less costly to pay the penalty amount instead of the parking rates that are in effect. Based on the analysis carried out, it has been determined that a penalty amount of \$75.00 would be needed to encourage compliance at these facilities.

Both the existing and proposed penalty amounts are low relative to the fine structures in place with other public agencies, including the Toronto Transit Commission (TTC), which has a fine amount of \$425.00 for passengers failing to display a valid TTC fair and Metrolinx, which has a fine amount of \$125.00 for customers parking in a reserved parking space without authorization. Table 3 details these amounts.

The penalty amount is also compared with penalty amounts for vehicle parking violations at Toronto Parks, Forestry & Recreation. Table 1 details the penalty amounts for parking violations at City of Toronto Parks, Forestry & Recreation, as found under Chapter 610 of the Municipal Code, Schedule A. The proposed penalty amount of \$75.00 is well below the penalty amounts for vehicle infractions at Parks, found to be \$100.00 and higher.

The increased penalty amount from \$30.00 to \$75.00 will encourage compliance at TPA's off-street parking facilities and will ensure an availability of short-term high turnover parking.
