Provincial Gas Tax

On March 27, 2006, City Council's Policy and Finance Committee authorized the execution of the standard annual Letter of Agreement with the Province for funding under the Dedicated Gas Tax Funds for Public Transportation Program for 2005-2006 and each subsequent year, as necessary.

Federal Gas Tax Fund

Transit Expansion Funding

On October 8, 2013, City Council authorized the City Manager to negotiate a contribution agreement with the federal government for up to \$660 million towards the cost of constructing the Scarborough Subway Extension project. http://app.toronto.ca/tmmis/viewAgendaltemHistory.do?item=2013.CC39.5

On July 12, 2016, City Council considered EX16.1 Developing Toronto's Transit Network Plan to 2031, including updates on several priority projects such as Scarborough Subway Extension, SmartTrack, Eglinton West LRT, Relief Line, and the Eglinton East LRT.

In April 2018, City Council approved a contribution of up to \$1.463B to the SmartTrack Stations Program subject to the terms and conditions described in Attachment 1 of report EX33.1. On April 16, 2019, City Council considered EX4.1d, a supplementary report to EX4.1 Toronto Transit Expansion Program – Update and Next Steps and directed the City Manager to advise the Province of Ontario and the Government of Canada that the City of Toronto will consider endorsing Provincial priorities for the City's PTIF2 allocation, subject to an assessment of the Province's proposed changed to Toronto's transit expansion program and further direction form City Council.

Federal Public Transit Infrastructure Fund

On December 13, 2016, City Council confirmed priority projects for PTIF, authorized the Mayor and City Manager to negotiate and enter into PTIF and Federal Clean Water Wastewater Fund agreements, and confirmed priorities and authorized the Mayor and City Manager to negotiate and enter into agreements for Phase 2 of the Government of Canada's infrastructure plan.

On November 7, 2017, City Council authorized the City Manager, in consultation with the Chief Financial Officer, to make amendments to the PTIF Phase 1 Project List by adding, deleting or changing project scope, subject to appropriate budget approvals, and the following conditions: a. the project has been approved by City Council within the 10-year Capital Budget and Plan, and has a capital financing strategy which assumed future Provincial/Federal funding or City Council gave direction to seek intergovernmental funding for unfunded (below-the-line) projects within the 10-Year Capital Budget and Plan; b. the project meets the Public Transit Infrastructure Fund Phase 1 program criteria, including meeting the overall annual program cash flow and completion deadlines; c. consideration has been given to best practices in capital planning and budgeting, including the prioritizing of projects that maintain assets in a state of good repair, and prioritizing larger projects that facilitate more efficient administration of the Public Transit Infrastructure Fund program; and d. Toronto Transit Commission Board authority has been obtained to proceed with Toronto Transit Commission projects.

Federal Disaster Mitigation and Adaptation Fund

On June 18, 2019, City Council adopted EX6.4 - Federal Disaster Mitigation and Adaptation Fund – Update, which authorized the City Manager in consultation with the Chief Financial Officer and Treasurer, to apply for federal funding under the Disaster Mitigation and Adaptation Fund for approved City Council capital projects that meet the funding eligibility criteria and completion timelines, including any additional rounds of intake announced by the Government of Canada.
