#### Re: PH 19.1 Keele Finch Plus Study - Final Report Official Plan Amendment 483 - Keele Finch Secondary Plan City of Toronto Ward 6, 7 TCDSB Trustee Ward 3

The Toronto Catholic District School Board (TCDSB) has reviewed PH 19.1 Keele Finch Plus Study - Final Report also known as Official Plan Amendment #483 for the Keele Finch Secondary Plan, scheduled for consideration by the Planning and Housing Committee on December 8, 2020.

The TCDSB has been involved in discussions with the City on policies related to the Keele Finch Secondary Plan area since early 2018, and most recently with the submission of comments in response to the Keele Finch Plus Secondary Plan - Draft OPA Policies dated March 23, 2020.

The TCDSB reiterates its <u>strong opposition</u> to proposed Secondary Streets adjacent to or in close proximity of both **St Wilfrid Catholic School** and **James Cardinal McGuigan Secondary School**, namely streets "<u>New Link 1</u>" and "<u>New Link 2</u>" as shown in "Map 6 - Public Street Plan" which are attached to these comments.

In comments dated March 23, 2020, the TCDSB cited the adverse impacts posed by New Link 1 on St Wilfrid Catholic School. These impacts included; **student safety**, increased congestion, noise pollution and emissions as well as **future unsafe pickup and drop off conditions** for students at the school. As mentioned in previous comments, St. Wilfrid Catholic School continues to <u>experience traffic safety issues</u> regarding increased vehicular traffic in the school parking lot and surrounding area and a new road would further worsen these issues.

Similarly, the TCDSB's comments cited the adverse impacts posed by New Link 2, running along the entire northern edge of James Cardinal McGuigan, would have on the school. These adverse impacts included; **student safety**, increased congestion, noise pollution and emissions. In addition, the introduction of a secondary road in this area will act as a vehicular bypass to Finch Avenue West, <u>creating future unsafe conditions for students</u> at James Cardinal McGuigan Catholic Secondary School as motorists avoid the congestion of Finch Avenue.



The TCDSB has made efforts to be communicative and work with the City on the policies related to the Keele Finch Secondary Plan being brought before the Planning and Housing Committee. However, the current version of OPA 483 being considered **negatively impacts continued student safety at both St Wilfrid Catholic School and James Cardinal McGuigan Catholic Secondary School** and raises concern with respect to the future safe operation of these TCDSB school sites.

The TCDSB wishes to continue to work with the City on refining the Secondary Plan so that TCDSB students/parents and staff at local schools can feel confident the plan is a safe and effective tool for building future complete communities in the Keele-Finch area

## AMENDMENT 483 TO THE OFFICIAL PLAN

# LANDS GENERALLY BOUNDED BY BLACK CREEK VALLEY TO THE WEST, THE MURRAY ROSS PARKWAY AND THE POND ROAD EAST OF KEELE STREET TO THE NORTH, THE EMPLOYMENT AREAS, RAIL CORRIDOR AND CERAMIC ROAD TO THE EAST, AND ASHWARREN ROAD AND DERRYDOWN ROAD TO THE SOUTH.

The Official Plan of the City of Toronto is amended as follows:

- 1. Map 16, Land Use Plan, is amended by re-designating lands shown on Schedule "I" from *Utility Corridors* to *Parks and Open Space Areas Parks*.
- 2. Map 3 of the Official Plan, Right-of-Way Widths Associated with Existing Major Streets, is amended by designating the planned right-of-way of:
  - a) Finch Avenue West, from west of Sentinel Road to Romfield Lane, to 40 metres, including the addition of "40 metres" within the map legend; and
  - b) Finch Avenue West, from Romfield Lane to Tangiers Road, to 42 metres, including the addition of "42 metres" within the map legend.
- 3. Schedule 1, Existing Minor Streets with Right-of-Way Widths Greater Than 20 Metres, is amended by replacing "To: Ceramic Road" in the following row, with the following:

4. Schedule 1, Existing Minor Streets with Right-of-Way Widths Greater Than 20 Metres, is amended by adding the following:
