I hope this email finds you well.

I wanted to be in touch to let you know that I received a copy of the staff report delivered to the ECDC regarding Reptilia's request for an exemption to the Animal By-law in relation to their potential tenancy at 245 Queens Quay West. As you likely know, Harbourfront Centre has been in discussions with Reptilia for more than a year.

I would note that the report indicates that there is no financial impact arising from the staff's recommendation, however, there is a significant and growing financial impact to Harbourfront Centre the longer the building remains untenanted. We will actively pursue alternatives if the exemption request does not proceed any further.

Presuming that Reptilia is able to adequately address the concerns raised in the report, Harbourfront Centre remains supportive of Reptilia as a potential tenant. We do, of course, appreciate and respect the City's process for considering these requests.

This week, I am happy to report that our skating rink has now opened in its temporary location on Harbourfront Centre's concert stage by the water.
