Provincial Gas Tax

On March 27, 2006, City Council's Policy and Finance Committee authorized the execution of the standard annual Letter of Agreement with the Province for funding under the Dedicated Gas Tax Funds for Public Transportation Program for 2005-2006 and each subsequent year, as necessary.

Federal Gas Tax Fund

On January 29, 2014, City Council authorized the execution of the 2014-2023 Administrative Agreement on the Federal Gas Tax Fund and directed that planned eligible projects be reported on annually through the capital budget process.

On February 19, 2020, City Council requested the federal government to permanently double the federal Gas Tax Fund and to increase its annual growth rate from 2 to 3.5 per cent, aligned with the request of the Federation of Canadian Municipalities.

Federal Disaster Mitigation and Adaptation Fund

On June 18, 2019, City Council adopted EX6.4 - Federal Disaster Mitigation and Adaptation Fund – Update, which authorized the City Manager in consultation with the Chief Financial Officer and Treasurer, to apply for federal funding under the Disaster Mitigation and Adaptation Fund for approved City Council capital projects that meet the funding eligibility criteria and completion timelines, including any additional rounds of intake announced by the Government of Canada.
