Dear Ms. Toft: Re: Toronto City Council Meeting, February 2 & 3, 2021 MM28.21 Calling on the Province to Phase-Out Gas-Fired Electricity Generation

Please distribute this letter to the members of Toronto City Council.

I am writing in support of Councillor Jennifer McKelvie's and Councillor Mike Layton's motion asking the Province of Ontario to phase-out all gas-fired electricity generation as soon as possible.

I am a health promoter at the South Riverdale Community Health Centre. We have worked for many years to reduce exposure to air, soil and water pollution because we have seen the direct health impacts. It is our understanding that the Port Lands Energy Centre (PEC), located about 1 Km from our heath centre, is the largest point source emitter of green house gasses in Toronto. We opposed it's construction because of the emissions and remain opposed to gas fired generation of power in general.

One only needs to look at the PEC during its long warm up to see the very visible brown plume lasting for hours. Toronto has made some needed commitments in it's TransformTO climate plan. Residents of Toronto need clean air. We know there are premature deaths and numerous other long-term health impacts from poor air quality due to the burning of fossil fuels.

In addition to health and climate change, gas supplies are finite. There are alternatives. We conducted some preliminary research indicating that there is a huge opportunity to reduce electricity demand through conservation. And many countries are shifting to renewables. We have a big opportunity with potential to import Quebec's hydro power.

We urge you to adopt this motion, to phase out gas fired electricity and to oppose the construction of any new gas-fired electricity plants.
