NOTICE OF PUBLIC MEETING

To be held by the Planning and Housing Committee (Under the Planning Act)

Proposed Amendments to the City of Toronto Zoning By-law 569-2013 Pertaining to Standards for Automobile Parking and Bicycle Parking

DATE: November 25, 2021

TIME: 10:00 a.m., or as soon as possible thereafter

PROPOSAL

The City of Toronto is proposing to enact amendments to the City of Toronto Zoning By-law 569-2013 to update parking standards for automobiles and bicycles. These changes are consistent with Official Plan objectives to discourage automobile dependence and to prioritize walking, cycling and transit over other passenger transportation modes.

Amendment to Zoning By-law 569-2013 to Update Parking Standards

The proposed zoning by-law amendment to update automobile parking standards will simplify parking rates by reducing the categories of existing land uses for the purposes of parking and creating two new parking policy areas. The zoning by-law amendment will eliminate most parking minimums, introduce parking maximums and update accessible parking requirements. Requirements for electric vehicle infrastructure are also introduced in the proposed zoning by-law amendment.

Amendment to Zoning By-law 569-2013 to Update Bicycle Parking Standards and Implement a Payment-in-Lieu of Bicycle Parking Policy

The proposed zoning by-law amendment to update bicycle parking standards will increase bicycle parking rates for Bicycle Zone 1 (the area of the City of Toronto bounded by the Humber River on the west, Lawrence Ave. on the north, Victoria Park Ave. on the east and Lake Ontario on the south). A Payment-in-Lieu of Bicycle Parking Policy will also be introduced, which permits a reduction of required short-term bicycle parking spaces through a payment to the City, as prescribed in Chapter 441 of the Toronto Municipal Code, Fees and Charges. Requirements for bicycle maintenance facilities are also introduced in the proposed zoning by-law amendment.

These changes may affect the approval of building permits, zoning certificates or other applications for a minor variance, a consent to sever, an amendment to a zoning by-law, an Official Plan amendment or a Minister's zoning order and any appeals of these matters, as well as outstanding appeals of Zoning By-law 569-2013.

Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendments are passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, Attention: Nancy Martins, Administrator, Planning and Housing Committee, at the address, fax number or e-mail set out in this notice.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website.
