RE: EX34.4 Priority Downtown Parks and Public Realm Opportunities

Tour, charter, and water taxi industry issue identification as part of the proposed Bathurst Quay signature waterfront park

The undersigned commercial tour, charter and water taxi operations in Toronto's inner harbour are writing in support of the proposed revitalisation of the *Bathurst Quay signature waterfront park at Spadina Quay and the Portland Slip, and to* **highlight the need for immediate action to ensure that berth spaces for our industry are replaced and expanded in the inner harbour.**

Our commercial tour, charter, and water taxi operations provide much-desired public access to waterbased recreation with an estimated 450,000 passenger vessel trips taken in 2019, and a contribution of approximately 500 jobs. Our industry has grown alongside new tourist experiences, parks, and substantial residential and office developments along the inner harbour. The story of Toronto's waterfront growth as a destination is incredible, and we are proud of contribution to that experience.

While the proposed revitalisation will improve the waterfront economy as a destination, we are concerned about the revitalisation's impact on the number of berths available for our industry. A loss of berths without adequate alternative facilities in place to replace them would have a significant impact on this currently growing and in-demand industry. This development in combination with work being done to develop public space at the Parliament Slip by Waterfront Toronto will require relocation of a significant number of operators in the inner harbour. New berths, and expanded berths, including new finger piers, must be in place in advance of relocation due to construction.

We also emphasize that it will be essential that the City of Toronto, its entities and partners (Ports Toronto, Waterfront Toronto, Harbourfront Centre, CreateTO) and all three levels of government must **prioritize recommendations in the 2020 Marine Use Strategy to ensure commercial tour, charter, and water taxi operations remain viable in Toronto's inner harbour.**

We understand as part of this consultation and design process moving forward today, the City of Toronto will work with our operators to identify solutions for relocation and additional berths. We also highlight and request immediate action on the following priorities outlined in the <u>2020 Marine Use</u> <u>Strategy [Link]</u>:

1) The expedited development of new finger piers for the tour and charter industry in locations across the central waterfront such as East Bayfront and at the Jack Layton Ferry Terminal as outlined in the *East Bayfront Precinct Plan* and the *Jack Layton Ferry Terminal Master Plan*. [2020 Marine Use Strategy item 4.5.1 / Additional Finger Piers]

2) The development of managed common user berths for the tour, charter, and water taxi industry to allow for boats to dock at locations near to the inner harbour and pickup passengers at a centralised location.

- Build out facilities to allow for the servicing of tour and charter boats close to the central waterfront, including maintenance, fulling, fresh water, supplies (food), and sewage disposal.

- Consider the construction of a large multi-user pier that could accommodate a new cruise terminal as well as accommodate berth space for the tour, charter, and water taxi industry. [2020 Marine Use Strategy item 4.5.4 / Multi-User Pier]


