No. 1994-0748. A BY-LAW

To repeal and reenact By-Law No. 608-91, being "A By-law To declare Purple Loosestrife a local weed in the City of Toronto." to reflect proposed Municipal Code Chapter 346, Weeds.

(Passed October 11, 1994.)

WHEREAS under subsection 10(1) of the Weeds Control Act, as Council has appointed a Municipal Weed Inspector, Council may by by-law designate as a local weed any plant that is not a noxious weed in respect to the whole or any part of the municipality, and under subsection 10(2) of that Act a plant that is so designated shall be deemed to be a noxious weed within the area to which the by-law applies;

AND WHEREAS Council at its meeting held on September 26 and 27, 1994 adopted Clause 39 of Neighbourhoods Committee Report No. 11 and authorized the introduction in Council of a bill to repeal and reenact By-law No. 608-91, being "A By-law To declare Purple Loosestrife a local weed in the City of Toronto." to reflect the drafting style and Interpretation Chapter of the City's proposed Municipal Code, with the additional revisions noted on Revised Chapter 346, on file with the City Clerk;

THEREFORE the Council of The Corporation of the City of Toronto enacts as follows:

1. The following weeds are designated as a local weed within the City's boundaries:

Common Name	Scientific Name
Purple Loosestrife	Lythrum salicaria

2. By-law No. 608-91, being "A By-law To declare Purple Loosestrife a local weed in the City of Toronto." is repealed.
3. This by-law comes into force after approval by the Minister of Agriculture and Food.

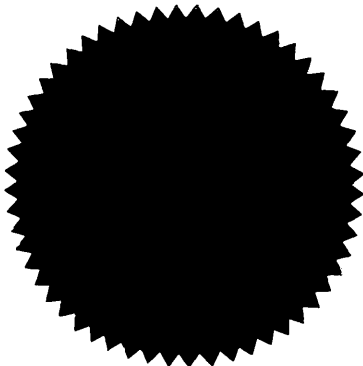
