## IN THE MATTER OF THE TORONTO EXTERNAL CONTRACTS INQUIRY

### AFFIDAVIT OF SUSAN CROSS

I, Susan Cross, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

### BACKGROUND

- 1. The information in this affidavit is supplemental to the affidavit I swore for the Toronto External Contracts Inquiry on November 18<sup>th</sup>, 2004 (the "November 18<sup>th</sup> Affidavit").
- My educational and professional background is set out at paragraphs 1 through 10 of the November 18<sup>th</sup> Affidavit.
- 3. I left Mr. Lyons' office in December of 2000 to work at Ketchum Canada Inc. doing fundraising work, but unfortunately I did not enjoy my new job. In April of 2001, I learned through Mr. Lyons who learned through Councillor Soknacki that Councillor Jane Pitfield was also looking for an Executive Assistant. I met with Councillor Pitfield and was hired to begin work about May 21, 2001. I am still working with Councillor Pitfield.

### BALL HSU & ASSOCIATES

4. In March of 2000, Mr. Lyons told me that one of his clients, Mr. Ball Hsu, wished to be able to support various candidates by contributing financial donations during the Toronto

municipal election campaign. Mr. Lyons said that because Mr. Hsu would be out of the country most of the time, he needed me to make the donations on behalf of Mr. Hsu as needed when the candidates to be supported were identified for Mr. Hsu by Mr. Lyons.

- 5. On March 9, 2000, Mr. Lyons wrote a confirming letter after a telephone conversation with Mr. Hsu requesting that a cheque be made payable to Morrison Brown Sosnovitch, LLP ("MBS") (TEC024108). Mr. Hsu wrote a reply letter to Mr. Lyons later that day (March 9, 2000) enclosing a \$15,000 cheque payable to MBS (TEC024109).
- 6. I subsequently followed up with a telephone call to Natalia Hsu, Mr. Hsu's wife, and explained that Mr. Lyons thought it best that the cheque be made payable to me, and that I would be sending the first cheque back to them. Mr. Lyons then wrote a second letter later that day to Mr. Hsu confirming that the cheque be made payable to me instead (TEC024110).
- 7. On March 15, 2000, I again followed up, this time by writing a memo to Mrs. Hsu, and explained that Mr. Lyons' didn't think the campaign funds should be processed through MBS, and requested that she forward a replacement cheque for \$15,000 payable to me (TEC024111). Shortly thereafter a second cheque made payable to me arrived.
- 8. I opened a separate chequing account for the Ball Hsu funds (the "Ball Hsu Account"). I went to the CIBC branch located at street level in our office building and opened an ordinary account there. (Account Application TEC026671, Signature Card TEC026675). I deposited

- a cheque payable to me from Ball Hsu and Associates in the amount of \$15,000 (TEC024115).
- 9. I believe Mr. Lyons generally wrote letters to his clients requesting specific support for various candidates. From time to time Mr. Lyons would write a letter addressed to Mr. Hsu to identify candidates who should be supported. For example, on March 7, 2000, Mr. Lyons wrote to Mr. Hsu requesting a \$500 donation to support Norm Kelly (TEC024106), enclosing a copy of Norm Kelly's fundraising letter (TEC024107). On March 29, 2000, the first cheque Mr. Lyons asked me write for Mr. Hsu was a donation for \$450 to the Norm Kelly campaign (TEC026272).
- 10. Mr. Lyons wrote to Mr. Hsu on March 29, 2000 requesting support for Gerry Altobello and Mario Giansante, and noted he already had funds (TEC024117). Between March 29, 2000 and October 25, 2000, I wrote twenty-nine cheques payable to municipal candidates' election campaigns at the direction of Mr. Lyons.
- 11. The amounts and particulars for each cheque I wrote on behalf of Mr. Hsu, at the direction of Mr. Lyons, together with any corresponding bank statements and receipts for each donation are set out in the table attached to this my Affidavit and marked as Schedule "A".
- 12. Mr. Lyons enclosed the cheques I wrote with a cover letter, often with other donations he had solicited for the candidates from other clients. For example, on April 3, 2000 Mr. Lyons wrote to Kyle Rae (TEC026460) enclosing various cheques he had solicited for Mr. Rae,

including one from me for \$350, with a notation in the letter "re: Ball Hsu" (TEC026274). On May 29, 2000, Mr. Lyons wrote to the Anne Johnston campaign (TEC026445), enclosing a \$250 cheque I completed at his direction. (TEC026286).

- 13. Of the \$15,000.00 I received from Ball Hsu, I donated a total of \$13,600.00 to candidates running for municipal office in 2000. I also wrote a cheque at Mr. Lyons' direction drawn on the Ball Hsu account to Nav Mangat (TEC026298), a Special Assistant in Mr. Lyons' office.
- 14. I used the remaining balance in the Ball Hsu Account (\$900.00) towards legal fees incurred as set out in paragraph 22 (below) and subsequently closed the Ball Hsu Account. I am not aware of Mr. Hsu making any attempts to contact me in order that remaining balance be returned to him. I am prepared to return this sum to Mr. Hsu, but I do not know how to contact him.
- 15. I did not apply for a rebate for any of the donations. I did not know at that time nor did I suspect or believe that there was anything improper or illegal when I made campaign donations on behalf of Mr. Hsu at Mr. Lyons' direction.

## THE NOVÆ RES URBIS ARTICLE

16. On Thursday May 10, 2001, at about six p.m., and just over one week before I was supposed to start at Councillor Pitfield's office, someone from *Novæ Res Urbis* tried to contact me and

left a message concerning an article they were writing about donations to municipal election candidates.

- 17. I called Mr. Lyons because I didn't know what to say. Mr. Lyons advised me not to bother calling back, particularly as it was after six p.m. Mr. Lyons also said that if I didn't speak to them they wouldn't have anything to write. Mr. Lyons said *Novæ Res Urbis* was published by people associated with Bruce Davis and the Urban Intelligence firm, which was his chief competitor in municipal lobbying in Toronto, and that we should accordingly be very careful what we said to them. I did not have a very good opinion of *Novæ Res Urbis*, and therefore was not interested in speaking with them in any event.
- 18. The next day, on May 11, 2001, an article appeared on the front page of *Novæ Res Urbis*, which identified me as a donor of more than \$9,000 to municipal electoral candidates (Article TEC025161). Janet Andrew of the City Election office was quoted in the article as saying a person can only donate money that belongs to them, and is therefore barred from giving on behalf of someone else. This was when I first realized I may have broken the law by making the donations on behalf of Mr. Hsu.
- 19. I was very concerned when I read this and telephoned Jane Pitfield. We discussed the story, and I pointed out where it was inaccurate identifying me as a government relations consultant and so forth. I told Ms. Pitfield I didn't know that making such donations on behalf of another person were illegal and said I would have told her that up front before I was hired if I

had known. Ms. Pitfield said we should wait a week or so before I started working with her and we could deal with it then.

- 20. In the meantime a member of the press called me, and I told this individual that I had no comment, but I was very worried. I started working at Ms. Pitfield's office. I spoke with Mr. Lyons again after the article came out and he said I was to say it was my own money and had freely chosen to support various municipal election candidates. I didn't think there was anything wrong with that, though I should really have questioned that explanation, but I trusted Mr. Lyons and I guess to some extent I panicked and was glad to have an answer to give people.
- 21. During the week of June 11, 2001 John Barber, a Globe and Mail reporter, came into Ms. Pitfield's office with a tape recorder running and questioned me about the cheques and what had happened. I told Mr. Barber what Mr. Lyons had told me to say, but I admit that was not the truth and I lied to Mr. Barber. I was simply very frightened by what I had got myself into, but I should have told the truth. I telephoned Mr. Lyons, who told me to write down everything that was said in my conversation with Mr. Barber so that he could have his lawyer review it. I wrote down notes of what I could recall of the conversation.
- 22. I told Ms. Pitfield about Mr. Barber's interview, and she suggested I speak to a lawyer. I was sent by her to George Rust D'Eye, who prepared an Affidavit for me detailing the donations I made on behalf of Ball Hsu, based mainly on the carbon copies I had for some of the cheques, which was sworn on June 20, 2001 (TEC023023). Since that time I have corrected

and supplemented the donations described in the June 21, 2001 Affidavit, now reflected in the donation summary attached to this my Affidavit as Schedule "A".
