

**IN THE MATTER OF THE TORONTO COMPUTER LEASING INQUIRY**

**AFFIDAVIT OF DEBORAH MORRISH**


I, Deborah Morrish, of the City of Toronto, in the Province of Ontario, make oath and say as follows:

1. I act as Power of Attorney for my father, Ken Morrish. My father has had at least one stroke, and is unable to testify or look after his own financial affairs. I confirm that he always drove his own car until about August 2001. He had a person who drove him on occasion starting in January 2000.
2. While presently I have my father's Power of Attorney, I have no knowledge of the day-to-day operations of his business prior to his stroke in November 2002.
3. At the request of Commission Counsel, I obtained all bank records for my father on personal accounts from every bank or financial institution where I knew or had any reason to believe that he had accounts. I have produced all of those records to Commission Counsel.
4. I have also reviewed those records. The transfers recorded in those records do not reveal to whom any transfers were made. I have no knowledge as to whether my father gave my husband, Ursula Jakobek, Tom Z. Jakobek or Maria Michie any cash in the period of October and November 1999.
5. I have been informed by a letter to my counsel that the T.D. Canada Trust confirmed that Mr. Ken Morrish's Investment matured on September 15<sup>th</sup> 1999 and was renewed on the same day with an Interest payout of \$43,542.16 in a Canadian Draft.

6. My father, when he provided support to my family and me, did so in the form of cash, gifts-in-kind or by way of cheque or bank drafts, such as the cheque and bank draft (\$45,000) paid to my husband in June 2000 as referenced in the Grant Thornton report. He also paid directly for some major expenses directly such as my car and the children's schools.
  
7. I have no knowledge as to whether my father's businesses and sources of income involved receipts or disbursements of large amounts of cash. I have no knowledge as to whether, if he received cash, he deposited it in the bank. My father always seemed to have significant amounts of cash on his person. On the occasion when my father had his stroke a significant amount of cash was found in his home.
  
8. Our family takes many trips together including four trips to Disneyworld in 1994, 1996, 1998 and 1999. My husband did all the planning for those trips. I don't recall any discussions about how the trips would be paid for.
  
9. I have no knowledge of any incoming or outgoing calls to my cell phone to or from Dash Domi.
  
10. I have no knowledge of whether any relationship ever existed between Dash Domi and my husband.
