Re: Royal de Versailles Jewellers Inc. - Summons to Witness

Further to your voice message and e-mail of 4:55 p.m. yesterday, and our e-mail response to you at 5:27 p.m., we have now been able to obtain instructions.

In response to your inquiry as to whether it is possible for Royal de Versailles to search for sales that may have been made to Tie Domi, only for the dates for which there are appraisals, we are instructed as follows.

It is not reasonably possible to search for paper records, if any, for sales made to Tie Domi on the specific dates for which there are appraisals.

Royal de Versailles has, however, been able to search electronic sales records, which are kept by week, and has been able to correlate sales

corresponding with the following appraisals numbered as in the Affidavit of Irit Shay sworn September 15, 2004.

1. Oyster Perpetual Cosmograph Daytona wristwatch corresponding sale in the week ended May 14, 2000;
2. 18k white gold Chopard necklace and "Happy Diamonds" pendant corresponding sale in the week ended May 14, 2000;
6. Oris Cronograph wristwatch corresponding sale for the week ended June 10, 2001;
8. ladies Chopard 18k white gold Jose Carreras corresponding sale for the week ended December 23, 2001; and
9. ladies Piaget, 18k white gold Polo wristwatch corresponding sale for the week ended January 1, 2002.


It is not possible from these records to correlate these sales to a specifically named buyer, but the products and numbers do correspond to those appraised for Tie Domi.

It is not possible to correlate the other 4 items appraised to sales during the respective weeks applicable to those respective appraisals.


