

IN THE MATTER OF THE TORONTO COMPUTER LEASING INQUIRY

AFFIDAVIT OF EMIL ZAMIARA

I, Emil Zamaria, of the City of Toronto, in the Province of Ontario, **MAKE OATH AND SAY:**

1. I have worked for the Toronto Parking Authority (TPA) since 1972. I have been the TPA's Internal Auditor since 1983 and have knowledge of the facts set out in this affidavit.
2. The TPA is a self-sustaining public corporation owned by the City of Toronto. The Council of the City of Toronto appoints a seven-member board of Directors to set the policies of the TPA and to oversee its operation.
3. The TPA provides 20,000 off-street spaces in 150 facilities including 19 parking garages, as well as 17,500 on-street spaces controlled by pay-and-display machines or meters. In addition, the Authority manages, on behalf of the Toronto Transit Commission, 12,500 spaces at their park and ride facilities and parking areas on behalf of the City's Parks and Recreation Department serving the waterfront parks during the summer season. The Toronto Parking Authority is the largest municipal parking operator in North America.
4. I have reviewed document COT025898, which I have attached to my affidavit as **Exhibit A**. It appears to be a copy of a parking receipt issued by the TPA. I have not reviewed the original receipt and have assumed that this document is a true copy of the original receipt. To enhance the clarity of this affidavit, line have been added to a copy of COT025898, which I have attached to my affidavit as **Exhibit B** ("Parking Receipt). Where my affidavit refers to a "Line" it is referring to Exhibit B.
5. Line 1 indicates that the TPA issued the Parking Receipt.

6. Line 2 indicates that the TPA issued the Parking Receipt at Carpark #36 - the Civic Square Garage. Carpark #36 is also referred to as the Nathan Phillips Square Garage and is located at 110 Queen Street West. It is the parking garage under Nathan Phillips Square and New City Hall. I have attached a map showing the location of Carpark 36 to my affidavit as **Exhibit C**. I have attached maps of the interior of Carpark 36 to my affidavit as **Exhibit D**.

7. There are four entrances to Carpark #36, which are marked by the arrows on Exhibit C: the north side of Queen St. West; the south side of Queen St. West (entrance only, no exit); the west side of Bay Street (entrance only, no exit); and Chestnut Street.

8. Carpark #36 contains approximately 2086 Spaces.

9. Drivers receive a ticket from a machine when they enter Carpark #36. When leaving Carpark #36, drivers provide the ticket to the cashier, pay the appropriate parking charge, and receive a receipt from the cashier.

10. Line 3 contains the TPA's GST number.

11. Line 4 contains the individual transaction number assigned to this parking transaction.

12. Line 5 receipt contains three pieces of information, which I will describe from right to left:

a) The text at the right hand margin "Out: 17:00 Nov/01/99" indicates that the driver left the garage at 17:00 h (or 5:00 p.m.) on November 1, 1999.

b) "OP-LN DAY-5", at the left hand margin, indicates two things

i) OP DAY – indicates day shift; and

ii) LN 5 – indicates that the driver left the garage using Lane 5. Lane 5 is located at the Chestnut Street exit and is staffed.

13. Lanes 1, 2 & 3 allow drivers to exit via Queen Street West or exit via Chestnut Street. Lanes 4 & 5 allow drivers to exit via Chestnut Street only.

14. The Chestnut Street exit is the closest exit to the new City Hall building. There are several staircases that lead from the parking garage to the surface of Nathan Phillips Square. The stairways have been given the names of animals, as indicated in Exhibit D.

15. Line 6 indicates that the driver entered Carpark #36 at 16:47 (or 4:47 p.m.). The driver was in the parking garage for 13 minutes. The Parking Receipt does not indicate what entrance the driver used to enter Carpark #36.

16. Line 10 indicates that the fee for parking 13 minutes was \$1.50.

17. Line 11 indicates that the driver paid cash for the parking fee. Because the driver paid cash, the TPA would not have any additional record of this transaction.

18. I have made this affidavit for the purposes of the Toronto Computer Leasing Inquiry and for no other purpose.
