Confirmation of Minutes

On motion by Councillor Pitfield, the Minutes of the Budget Advisory Committee meeting held on December 7, 2000 and January 25, 2001, were confirmed.

3.1 Appointment of Members of Council to Special Positions, Standing Committees, Other Committees and Special Purpose Bodies

The Budget Advisory Committee had before it a communication (December 8, 2000) from the City Clerk advising that City Council on December 5, 6 and 7, 2000, adopted, as amended, Clause No. 1 contained in Report No. 1 of the Striking Committee, headed "Appointment of Members of Council to Special Positions, Standing Committees, Other Committees, and Special Purpose Bodies", appointed the following Members of Council to the Budget Advisory Committee, for a term of office expiring May 31, 2002, and until their successors are appointed:

Mayor Mel Lastman, Member ex-officio; Councillor David Shiner, Chair; Councillor Paul Sutherland, Vice-Chair; Councillor David Soknacki; Councillor Olivia Chow; Councillor Ron Moeser; Councillor Joe Pantalone; and Councillor Jane Pitfield.

On motion by Councillor Pitfield, the Budget Advisory Committee received the aforementioned communication for information.

3.2 Toronto Zoo - Tendering of Advertising Contract

The Budget Advisory Committee had before it a report (June 27, 2000) from the City Clerk advising that the Audit Committee on June 26, 2000, received the report (June 1, 2000) from the City Auditor, entitled "Toronto Zoo - Tendering of Advertising Contract"; and directed that it be forwarded to the Budget Advisory Committee.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

(1) received the report (June 1, 2000) from the City Auditor; and

3.4 Facilities and Real Estate Division, Utilization of Emergency Capital Funds in Year 2000

The Budget Advisory Committee had before it a report (December 11, 2000) from the Commissioner of Corporate Services providing information concerning the utilization of the Emergency Capital funding provided as part of the year 2000 Capital Budget to address emergency building maintenance needs; and recommending that this report be received for information.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

- (1) received the aforementioned report for information; and
- (2) requested the Commissioner of Corporate Services to report to the Budget Advisory Committee on the funding provided in the 2000 and 2001 Operating Budget of Facilities and Real Estate for maintenance items.

3.5 Malvern District Library Capital Project

The Budget Advisory Committee had before it a report (January 8, 2001) from the City Librarian, addressed to the Toronto Public Library Board, presenting the results of the City's request to justify the expansion of the Malvern District Library and requesting the Toronto Public Library Board's approval to convey this information to the Policy and Finance Committee.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

- (1) referred the aforementioned report to the City Librarian for report thereon to the Budget Advisory Committee meeting of February 28, 2001, on the following:
 - (a) a breakdown of costs between the "pure" library component versus the "theatre" component and the funding to be provided by the community; and
 - (b) the cost per square foot to operate the current library versus projected cost once renovated; and
- (2) requested the Commissioner of Economic Development, Culture and Tourism to report to the Budget Advisory Committee on the need for a "theatre" component to the library versus additional recreational space.

Councillor Shiner resumed the Chair.

3.6 2001-2005 Capital Program and 20-Year Capital Forecast - Toronto Transit Commission

The Budget Advisory Committee had before it a report (January 18, 2001) from the City Clerk advising that the Policy and Finance Committee on January 18, 2001, referred the communication (December 15, 2000) from the General Secretary, Toronto Transit Commission, entitled "2001-2005 Capital Program and 20-Year Capital Forecast - Toronto Transit Commission", to the Budget Advisory Committee for consideration during the 2001 Capital Budget deliberations.

On motion by Councillor Soknacki, the Budget Advisory Committee deferred consideration of the aforementioned matter for consideration with the subject budget.

3.7 Emissions Testing Cost Analysis Comparison (Internal Versus External)

The Budget Advisory Committee had before it a report (October 31, 2000) from the Commissioner of Corporate Services responding to Council's request for information on the comparative costs of conducting emissions testing for gasoline and diesel powered fleet assets (in-house testing versus contracted services) during consideration of the 2001 Capital Budget; and recommending that:

- (1) the City continue to contract the Ontario Drive Clean emissions testing for 2001 for all types of vehicles; and
- (2) the decision on whether or not to implement in-house Ontario Drive Clean emissions testing for heavy diesel vehicles be deferred, to be dealt with in the Fleet Management Services business plan to be tabled in February 2001, to allow for the involvement of the new Director.

On motion by Councillor Pitfield, the Budget Advisory Committee deferred consideration of the aforementioned report for consideration with the Fleet Management Budget.

3.8 3Rs Implementation Plan for the City of Toronto

The Budget Advisory Committee had before it a communication (October 23, 2000) from the City Clerk advising that City Council on October 3, 4 and 5, 2000, and at its Special Meetings held on October 6, 2000, October 10, 11 and 12, 2000, referred the following Clause and motions to the Budget Advisory Committee for consideration during the 2001 Operating Budget process:

- (1) Clause No. 1 of Report No. 17 of The Works Committee, headed "3Rs Implementation Plan for the City of Toronto";
- (2) Moved by Councillor Chow:

"It is recommended that composters be provided at no charge to all schools (public, French, Catholic and private) and all licensed child care centres, by spring 2001."; and

(3) Moved by Councillor Johnston:

"It is recommended that \$1.3 million be provided from the Corporate Contingency Account in order to provide composters to all schools and child care centres located in the City of Toronto.".

On motion by Councillor Pitfield, the Budget Advisory Committee deferred consideration of the aforementioned matter for consideration with the Solid Waste Management Services Budget.

3.9 A Strategy for Implementing the Child Care Funding Approved in the 2000 Operating Budget

The Budget Advisory Committee had before it a communication (October 16, 2000) from the City Clerk advising that City Council on October 3, 4 and 5, 2000, and at its Special Meetings held on October 6, 2000, October 10, 11 and 12, 2000, forwarded to the Policy and Finance Committee and to the Budget Advisory Committee for consideration during the 2001 Operating Budget process, Clause No. 36 of Report No. 12 of The Policy and Finance Committee, headed "A Strategy for Implementing the Child Care Funding Approved in the 2000 Operating Budget".

On motion by Councillor Moeser, the Budget Advisory Committee deferred consideration of the aforementioned matter for consideration with the Children's Services Budget.

3.10 Service Road Implementation - North Yonge Centre Plan Service Road - North York Centre

The Budget Advisory Committee had before it a communication (October 26, 2000) from the City Clerk advising that City Council on October 3, 4 and 5, 2000, and at its Special Meetings held on October 6, 2000, October 10, 11 and 12, 2000, struck out and referred to the Budget Advisory Committee for further consideration during the 2001 Capital Budget process, Clause No. 51 of Report No. 10 of The North York Community Council, headed "Service Road Implementation - North Yonge Centre Plan Service Road - North York Centre".

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

(1) deferred consideration of the aforementioned matter for consideration with the Transportation Services Budget; and

(2) requested the Chief Financial Officer and Treasurer to report to the Budget Advisory Committee at that time on the funds available for this project.

Councillor Shiner resumed the Chair.

3.11 Toronto Arts Council - Long-Term Administrative/Budgetary Approach

The Budget Advisory Committee had before it a report (January 23, 2001) from the Commissioner of Economic Development, Culture and Tourism responding to the Budget Advisory Committee's request, at its meeting held on April 14, 2000, for a report on the provision of additional administration assistance to the Toronto Arts Council through the Culture Division and City Council's adoption of the recommendations contained in the report (April 10, 2000) from the Commissioner of Economic Development, Culture and Tourism; and recommending that:

- (1) the grant from the City of Toronto to the Toronto Arts Council (TAC) for the adjudication and disbursement of arts and culture grants be termed a grant for TAC "Operations" rather than TAC "Administration";
- (2) for purposes of analysis, the City of Toronto grant to the TAC for disbursement to the arts and culture community and the City of Toronto grant to the TAC for its "Operations" be included in one funding envelope;
- (3) the City of Toronto grant to the TAC for its "Operations" be used solely for the expenses directly related to the adjudication and disbursement of arts and culture grants;
- (4) on an annual basis, the TAC present its request to Council for a grant for its "Operations" based on a percentage of the funding envelope;
- (5) in 2001, the TAC grant request for "Operations" not exceed 10 percent of the funding envelope; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Soknacki, the Budget Advisory Committee referred this item to the Economic Development and Parks Committee for its meeting of February 12, 2001, for consideration with Item No. 9.

3.12 Environmental Plan "Clean, Green and Healthy: A Plan for an Environmentally Sustainable Toronto": Implications for Public Health

The Budget Advisory Committee had before it a report (January 23, 2001) from the City Clerk advising that the Board of Health on January 22, 2001, recommended the addition of \$201,327.00 (gross) and \$100,663.00 (net) to the 2001 Public Health operating budget to implement the first phase of priority recommendations identified in the Chief Administrative Officer's report on the Resource Implications of the Environmental Plan.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

- (1) deferred consideration of the foregoing report for consideration with the Board of Health Operating Budget; and
- (2) requested the Commissioner of Community and Neighbourhood Services and the Medical Officer of Health to provide a ranking of all its programs, including the new proposed programs within its 2000 net approved Operating Budget.

Councillor Shiner resumed the Chair.

3.13 Continuance of Tenant Support Grants Program

The Budget Advisory Committee had before it a communication (February 2, 2001) from the City Clerk advising that Council, at its meeting held on January 30, 31 and February 1, 2001, adopted a motion, moved by Councillor Walker, seconded by Councillor Pitfield, recommending that:

- (1) additional funds of \$37,500.00 be approved for the Tenant Support Grants Program such funds to be provided from the Corporate Contingency Fund, in order to assist eligible tenant groups who apply for the grants between now and March 31, 2001;
- (2) the Tenant Support Grants Program and the Outreach and Organizing Program be reinstated in 2001 and established as an annual program at a funding level of \$300,000.00;
- (3) the Tenant Support Grants Program and the Outreach and Organizing Program and associated budget be included in the 2001 budget considerations; and
- (4) this Notice of Motion also be referred to the Budget Advisory Committee.

Councillor Michael Walker, Ward 22 St. Paul's, appeared before the Budget Advisory Committee in connection with the foregoing matter.

A. Councillor Pitfield moved that the Budget Advisory Committee refer the aforementioned communication to the Community Services Committee for consideration at its meeting of February 12, 2001.

3.14 2001 Capital Program and 2001 Operating Budget Review Agencies, Boards and Commissions

The Budget Advisory Committee began its review of the 2001 Capital Program and 2001 Operating Budget.

Toronto Transit Commission - 2001 Capital Program

The Budget Advisory Committee had before it the 2001 Capital Program for the Toronto Transit Commission, recommending that:

- the 2001 to 2005 recommended capital program of the Toronto Transit Commission, excluding Sheppard Subway, consisting of 44 new and change in scope projects with a total project cost of \$811.923 million with a cash flow commitments of \$66.039 million in 2001; \$161.09 million in 2002; \$199.233 million in 2003; \$184.642 million in 2004; and \$200.912 million in 2005 as outlined in Appendix "B", be approved;
- (2) new debt service costs, as outlined in Appendix "A", totalling \$125.598 million by 2006 resulting from the approval of the 2001 to 2005 recommended capital program with incremental operating budget impacts of \$7.334 million in 2001, \$29.088 in 2002, \$22.637 million in 2003, \$25.675 million in 2004, \$22.534 million in 2005 and \$18.330 million in 2006 be approved for inclusion in the 2001 and future operating budgets;
- (3) the operating budget impacts that result in savings of \$0.996 million in 2001, \$1.014 million in 2002, \$3.299 million in 2003, \$0.122 million in 2004 and remain virtually unchanged in 2005 for the TTC, excluding the Sheppard Subway; and increased expenditures from Sheppard Subway of \$4.8 million in 2002, and \$2.8 million in 2003 and subsequent savings of \$0.7 million in 2004 and an additional \$0.2 million in 2005, as outlined in Appendix "A", be approved;
- (4) for the purpose of establishing spending control, the recommended 2001 to 2005 capital program for the TTC, excluding the Sheppard Subway, with a total cash flow of \$1.049,155 billion (\$811.923 new and change in scope, and \$237.233 previously approved); and consisting of cash flows of \$253.596 million in 2001, \$185.505 million in 2002, \$218.219 million in 2003, \$188.516 million in 2004, and \$203.319 million in 2005 as outlined in Appendix "D", be approved;
- (5) the TTC report directly to the Policy and Finance Committee with a strategy on implementing the \$400.431 million unspecified reduction relating to the five year capital plan submission; the yearly reductions are as follows: \$7.493 million in 2001; \$60.388 million in 2002; \$131.717 million in 2003; \$117.359 million in 2004; and \$84.074 million in 2005;
- (6) the 66 previously approved sub-projects from prior years capital programs, as outlined in Appendix "E", be closed;

- (7) for the purpose of establishing spending control, the recommended 2001 to 2005 capital program for the TTC Sheppard Subway project with a total cash flow of \$161.861 million, with cash flow requirements by year of: \$112.316 million in 2001; \$49.350 million in 2002; and \$0.150 million in 2003, be approved as outlined in Appendix "C"; and
- (8) the Inventory of Existing Infrastructure (as shown on page 9 Appendix "A" Section III) is currently a work in progress; the purpose of the chart analysis regarding the benefits to be derived from inventory maintenance and expansion; to facilitate this analysis, it is recommended that the TTC provide needed information as may be presently missing or unknown; specifically, statistics related to the average age, square-footage and capacity of various assets.

Mr. Rick Ducharme, Chief General Manager, and Mr. Vincent Rodo, General Secretary, Toronto Transit Commission, gave an overview presentation respecting the Toronto Transit Commission 2001 Capital Program.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

- A. Councillor Shiner moved that the Budget Advisory Committee:
 - (1) defer consideration of the 2002 to 2005 Toronto Transit Capital Budget and request the Chief General Manager of the Toronto Transit Commission to amend the said budget and the consequences thereof to be within the City's target envelope;
 - (2) request the Chief General Manager of the Toronto Transit Commission to present its 2001 Operating Budget to the special Budget Advisory Committee meeting of February 23, 2001;
 - (3) request the Chief Administrative Officer and the Chief Financial Officer and Treasurer to attend the Toronto Transit Commission meeting at which the operating and capital budgets are to be presented to the Board and request permission to make a presentation on the City of Toronto's 2001 and beyond financial status and the effect of the Toronto Transit Commission's budget on the City; and
 - (4) request the Chief General Manager, Toronto Transit Commission, to report to the Budget Advisory Committee on the following:
 - (a) the ridership levels from 1987 to 2001;

(b)	the number of vehicles that deliver service with a breakdown between buses, streetcars, subways and support vehicles;
(c)	capital expenditures per category to maintain the aforementioned vehicles;
(d)	what was spent on the state of good repair and expansion of buildings and capital assets;
(e)	information technology expenditures, including hardware and software costs on a yearly basis for the amount purchased and the dollar value on the amount that was leased; and
(f)	consultant costs, contract costs, travel expenditures and/or any other information that City staff may require to compare historical expenditures to present and future operating projections.

 - (1) the benchmark percentage used by the TTC for the 'state of good repair' for replacement of surface and subway tracks, i.e., total trackage and total tonnage per year, and other significant items in the transit capital budget and provide a comparison in that regard with New York, Chicago and Washington; and
 - (2) expanding the third party signage in certain key locations throughout the City of Toronto; and further that the Urban Design staff be requested to provide guidelines in this regard.

- C. Councillor Pitfield moved that:
 - (1) the General Manager, Toronto Transit Commission, be requested to report to the Budget Advisory Committee on the following:
 - (a) the need to continue aggressively expanding garages and whether this can be deferred in 2001;
 - (b) potential garage sites that the City no longer requires;
 - (c) the funding formula for link ups with GO transit; and
 - (d) the state of good repair for the TTC facilities, i.e., age of building, etc.; and
 - (2) the Chief Financial Officer and Treasurer be requested to report to the Budget Advisory Committee on the allocation of funding in the TTC and Works Department budgets for transit shelters and comment on these expenditures as they relate to the City's relationship with Mediacom.

Toronto Parking Authority - 2001 Capital Program and 2001 Operating Budget

The Budget Advisory Committee had before it the 2001 Capital Program for the Toronto Parking Authority, recommending that:

- the 2001-2005 recommended capital program for the Toronto Parking Authority, consisting of 21 new projects with a total project cost of \$51.975 million with cash flow commitments of \$9.300 million in 2001, \$7.875 million in 2002, \$10.950 million in 2003, \$6.750 million in 2004 and \$17.100 million in 2005 as outlined in Appendix "B" be approved;
- (2) net program revenues, as outlined in Appendix "A", totalling \$3.920 million in 2001 resulting from the approval of the 2001-2005 recommended capital program be approved for inclusion in the 2001 and future operating budgets;
- (3) for the purpose of establishing spending control, the recommended 2001-2005 capital program for the Toronto Parking Authority, with a total cash flow of \$94.916 million, with a cash flow of \$37.891 million, in 2001, \$15.125 million in 2002, \$18.050 million in 2003, \$6.750 million in 2004 and \$17.100 million in 2005 as outlined in Appendix "D" be approved;
- (4) the three previously approved projects from the 1999 and prior years capital program, as outlined in Appendix "E" be closed and that the funds be applied to financing the TPA 2001-2005 capital program;
- (5) Toronto Parking Authority provide, prior to the final deliberations on the capital program for 2001-2005, a detailed listing of previously approved projects, outlining year of approval and percentage of completion and that Toronto Parking Authority and Budget Services Division provide recommendations with respect to Recommendation No. (6) following; and
- (6) following the fifth year approval of a project by Council, if no expenditures are incurred for such projects, the City rescind the project approval unless the Toronto Parking Authority can provide reasonable justification to retain the approval for another year; otherwise the project authorization will be cancelled and the funds returned to the City.

The Budget Advisory Committee also had before it the 2001 Operating Budget for the Toronto Parking Authority, recommending that:

(1) the 2001 Recommended Operating Budget of \$33.975 million gross and \$(41.250) million net, comprised of the following services, be approved:

(2) the Chief Administrative Officer and the Chief Financial Officer and Treasurer, in conjunction with the President, Toronto Parking Authority, report back to the Budget Advisory Committee before its final deliberation of the 2001 Operating Budget on any change to the City's Revenue Sharing Agreement with the Toronto Parking Authority.

Mr. Maurice Anderson, President, and Mr. Gerard C. Daigle, Chief Financial Officer, Toronto Parking Authority, appeared before the Budget Advisory Committee in connection with the foregoing matter and answered Members' questions.

- A. Councillor Soknacki moved that:
 - (1) the President of the Toronto Parking Authority be requested to report to the Budget Advisory Committee on the following:
 - (a) in consultation with the Chief Financial Officer and Treasurer, on establishing fewer capital accounts for the acquisition of properties;
 - (b) a review of the Toronto Parking Authority Sharing Agreement and parking enforcement jurisdiction issues;
 - (c) the metered spaces approved but not yet installed and the reasons therefor; and
 - (d) reconsideration of the Toronto Parking Authority gross revenue target for the 2001 budget and report back on how a greater target can be attained;

- (2) the Chief Administrative Officer and the Chief Financial Officer and Treasurer, and relevant staff as may be assigned, be requested to comment on whether parking enforcement is better within the jurisdiction of the Toronto Police Service or the Toronto Parking Authority;

Toronto Zoo - 2001 Capital Program and 2001 Operating Budget

The Budget Advisory Committee had before it the 2001 Capital Program for the Toronto Zoo, recommending that:

- the 2001-2005 recommended capital program of the Toronto Zoo, consisting of seven new projects with a with a total new project cost of \$34.074 million with cash flow commitments of \$3.606 million in 2001, \$6.594 million in 2002, \$4.994 million in 2003, \$9.435 million in 2004, and \$9.445 million in 2005, as outlined in Appendix B be approved;
- (2) new debt service costs, as outlined in Appendix A, totalling \$12.925 million resulting from the approval of the 2001-2005 recommended capital program with incremental operating impacts of \$0.121 million in 2001, \$0.593 million in 2002, \$0.818 million in 2003, \$0.835 million in 2004, \$1.186 million in 2005, and \$1.086 million in 2006 be approved for inclusion in the 2001 and future operating budgets;
- (3) for the purpose of establishing spending controls, the recommended 2001-2005 capital program of the Toronto Zoo with a total cash flow of \$37.197 million; with a cash flow of, \$6.729 million in 2001, \$6.594 million in 2002, \$4.994 million in 2003, \$9.435 million in 2004, and \$9.445 million in 2005, as outlined in Appendix D be approved; and
- (4) the three previously approved projects from 1997 and prior years' capital program, as outlined in Appendix E be closed.

- (5) the General Manager of the Toronto Zoo be requested to report on the 2000 financial results of the Zoo to document that the Zoo has met the revenue deficiency condition for receipt of the \$0.300 million additional one-time funding for maintenance and repair items, as approved by City Council at its meeting on October 3, 4 and 5, 2000 and special meetings on October 6, 10, 11 and 12, 2000.
