Confirmation of Minutes.

On motion by Councillor Walker, the Minutes of the meeting of the Community Services Committee held on May 10, 2001, were confirmed.

7.1 Transfer of Care Delays on Toronto Emergency Medical Services.

The Committee had before it a report (May 28, 2001) from the Commissioner of Works and Emergency Services respecting the impact of delays in the transfer of patient care at Toronto area hospital emergency departments and the need to review and obtain approvals for strategies to offset the effects these delays are having on ambulance unit availability and response time; outlining the financial implications as a result of these delays; and recommending that:

- (1) City Council endorse the strategies outlined in this report to address the effects that transfer of patient care delays are having on paramedic response times;
- (2) the Chair of the Community Services Committee, Commissioner of Works and Emergency Services and the General Manager of Toronto Emergency Medical Services meet with the Chief Executive Officers of Toronto area hospitals to review the impacts that transfer of care delays are having on the Toronto Emergency Medical Services and to develop strategies to effectively deal with this trend;
- (3) City Council recommend to the Minister of Health and Long-Term Care (MOHLTC) that standards be established to allow for the timely transfer of patients from the care of paramedics to hospital emergency department staff to effect the immediate return of ambulances to active service;
- (4) City Council further advise the Minister of Health and Long-Term Care of the impact that transfer of care delays are having on ambulance availability and emergency response time within the City of Toronto;
- (5) the General Manager of Toronto Emergency Medical Services undertake immediate steps to protect emergency response time within the City of Toronto, including reductions in the provision of non-emergency inter-facility transfer services at such times and to the extent required to restore emergency response times in the City of Toronto, effective immediately;
- (6) the General Manager of Toronto Emergency Medical Services communicate directly with all health care agencies on the strategies to be employed to address emergency response time issues and further report back to Council on the effectiveness these plans have had on response time and ambulance availability;

- (7) the General Manager of Toronto Emergency Medical Services report monthly to the Community Services Committee on the impacts of the Toronto EMS budget due to strategies employed to protect emergency response times;
- (8) the General Manager of Toronto Emergency Medical Services continue to negotiate with the MOHLTC for funding for the costs directly attributable to the delays in the transfer of patient care and further to report back to the September meeting of the Community Services Committee on the status of these negotiations; and
- (9) the appropriate City officials be given the authority to give effect thereto.

The Committee also had before it a copy of a communication (June 6, 2001), addressed to the Chief Executive Officers, Acute Care Hospitals with Emergency Departments' Managers, from Mr. John A. King, Assistant Deputy Minister, Ministry of Health and Long-Term Care, respecting "Accountability for Patients Arriving in Emergency Departments by Ambulance Services."

The Committee:

- (i) recommended to Council the adoption of the aforementioned report, subject to amending Recommendation No. (2) by adding the words "Seniors' Advocate" after the word "Committee", so that such recommendation reads as follows:

"(2) the Chair of the Community Services Committee, Seniors' Advocate, Commissioner of Works and Emergency Services and the General Manager of Toronto Emergency Medical Services meet with the Chief Executive Officers of Toronto area hospitals to review the impacts that transfer of care delays are having on the Toronto Emergency Medical Services and to develop strategies to effectively deal with this trend;"

and further that a copy of the report be forwarded to the Policy and Finance Committee and the Budget Advisory Committee for information;

- (ii) directed that the Commissioner of Works and Emergency Services and the General Manager, Toronto Emergency Medical Services be requested to report directly to Council for its meeting on June 26, 2001, on the result of:
 - (a) the meeting with the Chief Executive Officers of the Toronto area hospitals; and
 - (b) the negotiations with the Province of Ontario with respect to the \$724,000.00 required immediately to address the transfer of patient care delay crisis in Toronto; and

- (iii) directed that the Commissioner of Works and Emergency Services and the General Manager, Toronto Emergency Medical Services be requested to report to the next meeting of the Community Services Committee providing an analysis of the performance of each Toronto area hospital with regard to the delays experienced by paramedics in exercising the transfer of care of patients in emergency departments.

7.2 Update on Conversion of Toronto Emergency Medical Services to an All Advanced Life Support Paramedic System.

The Committee had before it a report (May 18, 2001) from the Commissioner of Works and Emergency Services providing an update on the activity and status of the previously approved conversion of Toronto Emergency Medical Services from a combination primary care paramedic and advanced care paramedic system to an all advanced care system; and recommending that:

- (1) this report be received for information; and

- (2) Toronto Council endorse continuation of paramedic upgrade training.

On motion by Councillor Mihevc, the Committee recommended to Council:

- (1) the adoption of the aforementioned report; and
- (2) that the Toronto Emergency Medical Service work with post-secondary institutions, such as Humber College and Centennial College, to ensure that prospective paramedics and other Emergency Medical Services employees are trained to the highest standard required for the City of Toronto's operations.

7.3 Provincial Funding of Land Ambulance Services.

The Committee had before it a report (May 22, 2001) from the Commissioner of Works and Emergency Services respecting the outcome of recent negotiations with the Ministry of Health and Long-Term Care for the funding of Land Ambulance Services; outlining the financial implications of the 2000 operating funding subsidy and noting that 2001 subsidy negotiations will commence once final agreement has been reached on all facets of the 2000 budget; and recommending that the report be received for information.

7.4 Leasing of Ambulances.

The Committee had before it a report (May 23, 2001) from the Commissioner of Works and Emergency Services responding to the request of the Committee to report on the potential of leasing ambulances rather than purchasing replacement ambulances as a potentially cost-savings measure; concluding that it would appear that there would be longer term financial benefits to continue with the purchase of ambulances through the current practices of the five-year vehicle replacement program; noting the reasons for this conclusion; and recommending that the report be received for information.

7.5 Toronto Fire Services Response to Recommendation Arising from the Inquest into the Deaths of Linda Elderkin and Paul Benson.

The Committee had before it a joint report (May 18, 2001) from the Commissioner of Works and Emergency Services and the Fire Chief providing a response to the Jury recommendations directed to Toronto Fire Services as a result of the Coroner's Inquest into the deaths of Linda Elderkin and Paul Benson at 2362 Queen Street East on January 16, 1999; noting that, although no financial implications are associated with the approval of this report at this time, an amount of \$3,956,103.00 would be required to respond to all of the recommendations from the Inquest; and recommending that this report be received as information and forwarded to the Mayor's Task Force on Fire Services for consideration and development of recommendations as part of its report back to the Community Services Committee on Fire Services resources.

On motion by Councillor Walker, the Committee recommended to Council the adoption of the aforementioned joint report; and further directed that a copy thereof be forwarded to the Chief Coroner of Ontario for information.

7.6 A.R. Clarke & Co. Tannery Blaze on Eastern Avenue.

The Committee had before it a report (May 22, 2001) from the Commissioner of Works and Emergency Services responding to the Committee's request to report on the tannery blaze fire at A. R. Clarke & Co. at 633 Eastern Avenue on March 27, 2001; providing a review of the protocol that deals with critical emergencies, the notification process, and the control of hazardous wastes and chemicals in buildings; and recommending that the report be received for information.

The Committee also had before it a communication (June 7, 2001) from Councillor Jack Layton, Ward 30, Toronto-Danforth, respecting the tannery blaze fire at A. R. Clarke & Co.; noting that three public meetings have been held with local residents to discuss the aftermath of the fire; and recommending that:

- (1) the Commissioner of Works and Emergency Services prepare an emergency management plan applicable to events such as fires in old factories and abandoned industrial sites in close proximity to residential areas that includes, but is not limited to:
 - (a) a lead co-ordinator who is responsible for liaising with various emergency services, City departments, provincial agencies, hydro and gas utilities, and any other organization providing vital community services;
 - (b) a process for notifying nearby residents of any interruption in vital services such as electricity;
 - (c) a process for temporarily housing residents who have to be evacuated from their homes due to health and safety issues; and
 - (d) a mechanism for developing a neighbourhood emergency response plan with the assistance of the local Councillor and City staff;

and that this emergency plan be presented to the Community Services Committee for public review in the Fall of 2001.

- (2) the Commissioner of Works and Emergency Services, in consultation with Toronto Public Health and Toronto Fire Services, undertake an inventory that identifies all old and/or abandoned factories in close proximity to residential areas that may contain contaminated materials on site which could pose a public health risk and that this inventory be made available to the public.

- (1) authority be given to the Homes for the Aged Division to write-off the arrears accumulated on behalf of A.H. while he was a resident at Kipling Acres; and

- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

7.13 Request for Quotation for the Supply and Delivery of Food and Related Supplies for the Child Care Centres.

The Committee had before it a joint report (May 24, 2001) from the Commissioner of Community and Neighbourhood Services and the Chief Financial Officer and Treasurer advising of the results of the Request for Quotation for the supply and delivery of Food and Related Supplies for the Child Care Centres for the Community and Neighbourhood Services Department, Children's Services Division for the period June 1, 2001 to April 30, 2002, with the City having the option to renew on an annual basis at marketplace prices at the time of renewal until April 30, 2004; and recommending that the bid submitted by the lowest bidder, Derry Foods Limited in the estimated amount of \$957,902.41 including all charges and applicable taxes for the supply and delivery of Food and Related Supplies be accepted for the period June 1, 2001 to April 30, 2002, renewable on an annual basis until April 30, 2004.

7.14 Toronto's Childcare Service Plan.

The Committee had before it a report (May 22, 2001) from the Commissioner of Community and Neighbourhood Services outlining the scope and intent of the Childcare Service Plan which has been prepared as part of the City's submission to the Ministry of Community and Social Services for provincial funding; and recommending that:

- (1) the implementation principles contained in the attached Childcare Service Plan be endorsed and the Plan be submitted to the Ministry of Community and Social Services in conjunction with the City's 2001 request for provincial subsidy based on the 2001 Operating Budget approved by Council for Children's Services;
- (2) approval be given to host up to six community meetings in the early fall of this year to secure input into the Childcare Service Plan from users of childcare services prior

to ward-based implementation planning; and

- (3) the appropriate City officials take the necessary action to give effect thereto.

The General Manager, Children's Services Division, gave an overhead presentation on the Childcare Service Plan.

On motion by Councillor Chow, the Committee:

- (i) recommended to Council the adoption of the aforementioned report, subject to amending Recommendation No. (2) to read as follows:

"(2) approval be given to host up to six community meetings in the early fall of this year to secure input into the Childcare Service Plan from users of childcare services prior to ward-based implementation planning; and further that discussion take place at such meetings on Canada's best practices, including the Quebec model of delivering \$5.00 per day child care, and the various challenges faced by the Children's Services Division resulting from provincial actions; and";

- (ii) directed that the Commissioner of Community and Neighbourhood Services be requested to report to the Community Services Committee in September 2001 on the result of negotiations with the provincial Ministry of Community and Social Services, particularly with respect to:

- compliance to the KPMG study;
- payment for playground reconstruction;
- payment for actual costs in operating childcare and family resource centres;
- financial impact of the Learning, Earning and Parenting (LEAP) Program; and
- the changing demographics of families being subsidized.

7.15 An Early Learning and Child Care Commission.

The Committee had before it a report (May 22, 2001) from the Commissioner of Community and Neighbourhood Services providing a response to the proposal to establish an Early Learning and Child Care Commission in Toronto; and recommending that:

- (1) the City endorse the establishment of a time-limited and independent Early Learning and Child Care Commission in Toronto to develop a communication and advocacy strategy to influence national and provincial policy and funding support for child care and early learning and development;
- (2) City officials participate as part of an Advisory Group to the three-person Commission and provide technical information and assistance as required;
- (3) the findings and recommendations of the Commission be forwarded to Council through the Children and Youth Action Committee and be considered in conjunction with the City's Action Plan for Children; and

7.18 Homeless Health Reference Group.

The Committee had before it a communication (May 23, 2001) from the Secretary, Board of Health, advising that the Board of Health on May 22, 2001, recommended the adoption of a joint report (May 22, 2001) from the Medical Officer of Health and the Commissioner of Community and Neighbourhood Services providing an update on the progress of the Homeless Health Reference Group; and wherein it recommended that:

- (1) the City of Toronto request that the teaching hospitals located in the City of Toronto, in collaboration with the Shelter Housing and Support Division, develop a common discharge protocol based on the best practices identified in this report;
- (2) the City of Toronto urge the Ministry of Health and Long-Term Care to complete negotiations with the Sherbourne Corporation to establish and fund a pilot project infirmary for people who are homeless in the City of Toronto in the 2001-2002 fiscal year, based on the principles identified in this report;
- (3) the Commissioner of Community and Neighbourhood Services conduct an inventory of existing homeless services and funding in order to determine the extent to which they meet the harm reduction principles identified in this report, and to develop strategies to address any shortfalls identified through the inventory;
- (4) the City of Toronto incorporate the harm reduction principles identified in this report in the provision of homeless services and grants and urge other service providers and funders of homeless services to do the same in order to ensure consistency and access

to services;

- (5) the City of Toronto urge the Provincial Government to:
 - (a) establish a provincial homeless health framework to specifically address the health care access issues experienced by people who are homeless and which identifies appropriate delivery models and funding sources;
 - (b) continue to invest in supportive and transitional housing; and
 - (c) develop an inter-ministerial process and strategies to address urgent gaps in housing, social and health services available to people who are homeless;
- (6) the City of Toronto continue to urge the Federal Government to invest in affordable housing to ensure that the health needs of people who are homeless are addressed; and
- (7) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mihevc, the Committee recommended to Council the adoption of the recommendation of the Board of Health contained in the aforementioned communication from the Secretary.

- (2) the City enter into a purchase of service agreement with the Federation of Metro Tenants' Associations (the Federation) at a maximum cost of \$150,000.00, in a form satisfactory to the City Solicitor, retaining the Federation to carry out the Outreach and Organizing component of the Tenant Defence Fund Program for a term commencing May 16, 2001, and ending May 15, 2002, which agreement shall be renewable annually at the option of the City;
- (3) Recommendations Nos. 1, 2, 3, 4, 5, 8, 10 and 11 of the Review be adopted and incorporated into the service agreement with the Federation;
- (4) Recommendations Nos. 6 and 7 of the Review be referred to the Commissioner of Community and Neighbourhood Services for consideration in light of the information available from the Ontario Rental Housing Tribunal (the Tribunal), and that the Federation's requirements under the service agreement be revised to better reflect the information it can obtain from the Tribunal;
- (5) Recommendation No. 9 of the Review, regarding the number of buildings with above-guideline applications (AGI) which the Federation is required to contact, that the service agreement clarify that the Federation be only required to initiate contact with all such buildings affected by providing notices of its services, and that the number of buildings be expanded to include those with demolition and condominium conversion applications in addition to AGI applications; and
- (6) the appropriate City officials be authorized to take the necessary action to give effect to these recommendations.

Ms. Pauline Hutchings, on behalf of Mr. Paul York, Greater Toronto Tenants' Association, appeared before it the Community Services Committee in connection with the foregoing matter, and submitted a brief in regard thereto.

The Committee had before it a report (June 4, 2001) from the Commissioner of Community and Neighbourhood Services providing an update on the application for a new Home for the Aged in Scarborough and the outcome of the bed award decisions made by the Ministry of Health and Long Term Care (MOHLTC); advising of the need to reconfirm the capital budget and timelines for the redevelopment of True Davidson Acres, given the decision to not award beds to the City of Toronto and recommending that:

- (1) staff report back on the results of the requested debriefing meeting with the MOHLTC, once the reasons for the non-approval of the proposed Scarborough home have been clarified;
- (2) the capital budget of \$24.0 million for the proposed new Scarborough home for the aged be cancelled, deleting the requested cashflow of \$1.0 million in 2001, \$10.0 million in 2002, \$10.0 million in 2003, and \$3.0 million in 2004;
- (3) the redevelopment of True Davidson Acres be deleted from the 2004-2006 period and rescheduled to the 2001-2004 period;
- (4) the approved \$21.6 million capital budget for the True Davidson Acres project be re-established with a cashflow of \$4.8 million in 2001, \$9.6 million in 2002, \$6.24 million in 2003, and \$960 thousand in 2004;

- (5) staff report back related to the details of the True Davidson Acres redevelopment, including the potential for leased space for an interim period of time, the impact on residents and staff, and a two-phase construction project, once all of the details have been confirmed.
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Johnston moved that the Committee recommend to the Policy and Finance Committee, and Council:

- (a) the adoption of the aforementioned report; and
- (b) that the City-owned land that was designated for the proposed Scarborough Home for the Aged in Scarborough Southwest, Ward 35, be used for affordable housing.

The Chair appointed Councillor Chow Acting Chair, and vacated the Chair.
