# 3.2 Ashbridges Bay Treatment Plant Mediation Agreement – Implementation and Compliance Monitoring Committee Review of City's Compliance. (Ward 32 – Beaches-East York)

The Works Committee had before it a report (January 24, 2001) from the Commissioner of Works and Emergency Services submitting the Interim Report prepared by the Implementation and Compliance Monitoring Committee (ICMC) for the Main (Ashbridges Bay) Treatment Plant, which provides a public review of the City's compliance with the Ashbridges Bay Treatment Plant Mediation Agreement; noting that, based on its review, the ICMC wished to draw to the attention of the Works Committee and City Council certain items that, in its opinion, warrant consideration; providing clarification and information on initiatives relevant to the items raised by the ICMC report; and recommending that the attached Implementation and Compliance Monitoring Committee review be received for information.

Councillor Layton moved that:

- (1) a committee be established to develop a Biosolids Management Plan, to consider options for the treatment of biosolids, including addressing the issue of unnecessary transportation of biosolids from the Humber Treatment Plant to the Ashbridges Bay Treatment Plant, and that such committee include representation from the Toronto Civic Employees' Union – CUPE Local 416;
- (2) the Commissioner of Works and Emergency Services be requested to submit a report to the Works Committee on the terms of reference and membership of the proposed committee; and
- (3) requested the Commissioner of Works and Emergency Services, in consultation with the Toronto and Region Conservation Authority, to report back to the Committee on resolving concerns respecting stormwater and combined sewer overflows into the Coastworth Cut and the impact on surrounding development.

# 3.3 Proposed Residential Solid Waste Collection By-law.

The Works Committee had before it a communication (August 11, 2000) from the City Clerk advising that City Council, at its meeting on August 1, 2, 3 and 4, 2000, had before it Clause No. 3 contained in Report No. 15 of The Works Committee, headed "Proposed Residential Solid Waste Collection By-law", wherein the Committee recommended the adoption of the report dated June 28, 2000, from the Commissioner of Works and Emergency Services which recommended that:

(1) the Residential Solid Waste Collection By-law, consolidating and harmonizing the residential components of the former Area Municipalities' solid waste collection by-laws, be enacted;

- (2) the following by-laws continue to be in effect, provided that in the event of a conflict between the Residential Solid Waste Collection By-law and a by-law referred to below, the Residential Solid Waste Collection By-law will prevail:
  - Chapter 309, City of Toronto Municipal Code, as amended;
  - Chapter 149, Etobicoke Municipal Code, as amended;
  - By-law 1-86, as amended;
  - By-law 2890-78, as amended;
  - By-law 24478, as amended; and
  - By-law 21732, as amended;
- (3) authority be granted for the introduction of the necessary Bill to give effect thereto;
- (4) staff be authorized to take all steps necessary to enforce the Residential Solid Waste Collection By-law;
- (5) residents of the City of Toronto be advised accordingly;
- (6) the Commissioner of Works and Emergency Services be given full authority to discontinue solid waste collection services at any residential location due to non-compliance with the by-law, and only in the event that the Ward Councillor is of the opinion that the location should remain eligible for solid waste collection services while in contravention of the by-law, will the issue be sent to the Works Committee and Council for resolution; and
- (7) the Commissioner of Works and Emergency Services be directed to initiate site investigations at multiple household residential locations and authorize the adjustment of garbage and/or recycling collection service based on the protocol identified in this report;

and further advising that Council directed that the aforementioned Clause be struck out and referred back to the Works Committee for further consideration.

The Committee also had before it the following reports:

- (i) (January 23, 2001) from the Commissioner of Works and Emergency Services, entitled "Proposed Residential Solid Waste Collection By-law: Set Fines and Clean-Up Orders", recommending that:
  - (1) Section 19 of the proposed Residential Solid Waste Collection By-law, presented to Council in the report dated June 28, 2000, from the Commissioner of Works

and Emergency Services be amended, for the purposes of facilitating the short form wording only, to include the following two sub-clauses:

- "19.1 No person shall:
- 19.1 (g) set out any waste for collection unless it is in appropriate Regulation Containers as specified in this By-law;
- 19.1 (h) set out any waste in a Regulation Container that is not in good working order.";
- (2) the revised set fines provided as Attachment 2 in this report replace the original set fines presented to Council in the report dated June 28, 2000, from the Commissioner of Works and Emergency Services entitled "Residential Solid Waste Collection By-law";
- (3) upon approval of the proposed Residential Solid Waste Collection By-law, the Legal Services Division be authorized to forward the fine schedule to the Ministry of the Attorney General for approval;
- (4) following receipt of approval from the Ministry of the Attorney General, staff be directed to apply the fine schedule as part of the residential by-law enforcement procedure; and
- (5) following approval of the proposed Residential Solid Waste Collection By-law, staff be authorized to issue clean-up orders for material that is deemed, by a By-law Enforcement Officer, to be offensive to the public or attractive to animals and collect the cost in a like manner as taxes;
- (ii) (January 23, 2001) from the Commissioner of Works and Emergency Services, entitled "Proposed Residential Solid Waste Collection By-law: Mandatory Recycling at Existing Multiple Household Residential Locations Where the City Provides Collection Services", responding to the request of Council in October 2000 for a report on a by-law for mandatory recycling for existing apartment buildings; highlighting section 2.3 of the proposed Residential Solid Waste Collection By-law that will make recycling mandatory at all existing and new multiple household residential locations where the City provides collection services, which will assist the City in achieving its diversion targets; and recommending that this report be received for information;

- (iii) (January 24, 2001) from the Commissioner of Works and Emergency Services, entitled "Proposed Solid Waste Collection By-law: Options for Household Waste Containers Above the Collection Item Limit", recommending that:
  - (1) Section 8.1 of the proposed Residential Solid Waste Collection By-law be deleted and replaced with the following Section 8.1:

"No owner who receives Curbside Collection shall set out for collection any combination of Garbage Containers and/or Bulky Items which exceeds six (6) in number";

- (2) residents be directed to continue to use the existing options available to them to deal with garbage in excess of the collection item limit;
- (3) effective January 1, 2002, residents receiving curbside waste collection who wish to have extra items collected may purchase tags from the City at a cost of \$3.00 each, which must be affixed to each item in excess of the set out limit;
- (4) staff report back before the end of 2001 on the production, promotion and distribution of the special tags, including all associated costs;
- (5) that an item limit per household and fee schedule be implemented as follows:
  - (i) 2001 No more than six (6) garbage items shall be collected weekly;
  - January 1, 2002 No more than five (5) garbage items shall be collected weekly unless tags, provided at a cost of \$3.00 each, are affixed to each item above the limit;
  - January 1, 2003 No more than four (4) garbage items shall be collected weekly unless tags, provided at a cost of \$3.00 each, are affixed to each item above the limit;
  - (iv) beginning in 2001, grace periods will be provided whereby the item limit will be increased by two bags per household per week in the last two weeks of December of each year, in the week following the Thanksgiving long weekend and the week following the Victoria Day long weekend; and
  - (v) item limits, cost of tags and provision of grace periods for 2004 and

beyond will be reviewed in 2003;

- (6) staff be authorized to amend the Residential Solid Waste Collection By-law to include the requirement to purchase tags for items over the set out limit and the item limit implementation schedule;
- (7) staff review the charge of \$3.00 per collection item following the first 12 months of implementation and from time to time following that, to determine the actual use of the service and adjust the charge, up or down, with the approval of Council, to ensure that all associated costs related to the service are recovered; and
- (8) upon approval of the Solid Waste Collection By-law, clean-up orders will be issued at locations that choose not to use any of the approved options; and

The Committee also had before it a communication (February 5, 2001) from Councillor Howard Moscoe, Ward 15 – Eglinton-Lawrence, respecting the grace periods for item limits per household in the proposed Residential Solid Waste Collection By-law; and suggesting that Recommendation No. (5)(iv) in the report dated January 24, 2001, from the Commissioner of Works and Emergency Services be amended by adding thereto "and in the two weeks during Passover in designated areas of the City" and "and the week following Ramadan in designated areas of the City".

Councillor Sandra Bussin, Ward 32 – Beaches-East York, appeared before the Committee in connection with the foregoing matter.

Councillor Layton moved the adoption of the aforementioned reports, subject to deferring those portions pertaining to the bag limits and extra bag charges until the plan to introduce organics collection is in place and promoted. (**Redundant**)

Councillor Balkissoon moved the adoption of the aforementioned report dated June 28, 2000, from the Commissioner of Works and Emergency Services, subject to the following amendments:

- (A) the adoption of the following Recommendations embodied in the aforementioned report dated January 23, 2001, from the Commissioner of Works and Emergency Services, entitled "Set Fines and Clean-Up Orders":
  - "(1) Section 19 of the proposed Residential Solid Waste Collection By-law, presented to Council in the report dated June 28, 2000,

from the Commissioner of Works and Emergency Services, be amended, for the purposes of facilitating the short form wording only, to include the following two sub-clauses:

- 19.1 No person shall:
- 19.1 (g) set out any waste for collection unless it is in appropriate Regulation Containers as specified in this By-law;
- 19.1 (h) set out any waste in a Regulation Container that is not in good working order";
- (2) the revised set fines provided as Attachment 2 in this report replace the original set fines presented to Council in the report dated June 28, 2000, from the Commissioner of Works and Emergency Services entitled "Residential Solid Waste Collection By-law";
- (3) upon approval of the proposed Residential Solid Waste Collection By-law, the Legal Services Division be authorized to forward the fine schedule to the Ministry of the Attorney General for approval;

- (B) the adoption of the following Recommendations Nos. (1), (2) and (8) embodied in the aforementioned report dated January 24, 2001, from the Commissioner of Works and Emergency Services, entitled "Options for Household Waste Containers above the Collection Limit":

- "(1) Section 8.1 of the proposed Residential Solid Waste Collection By-law be deleted and replaced with the following Section 8.1:
  "No owner who receives Curbside Collection shall set out for collection any combination of Garbage Containers and/or Bulky Items which exceeds six (6) in number";"
- "(2) residents be directed to continue to use the existing options available to them to deal with garbage in excess of the collection item limit;" and
- "(8) upon approval of the Solid Waste Collection By-law, clean-up orders will be issued at locations that choose not to use any of the approved options".

Councillor Jones moved that the foregoing motion by Councillor Balkissoon be amended by amending the proposed Residential Solid Waste Collection By-law to provide that the set-out time be 6:00 p.m. from November to April. (**Carried**)

Councillor Lindsay Luby moved that the Commissioner of Works and Emergency Services be requested to submit a report to the Committee by the end of 2001 on the incidences of illegal dumping. (**Carried**)

## **3.4** Transportation of Waste to Michigan.

The Works Committee had before it a communication (December 13, 2000) from Mayor Anne Marie DeCicco, City of London, advising that members of a coalition of southwestern Ontario municipalities, known as the Southwestern Ontario Trash Coalition (SWOT), are very concerned about the transportation of Toronto garbage to Michigan; and requesting the opportunity to appear before the Committee to address some of the issues surrounding this initiative.

The Committee also had before it the following communications:

(i) (October 12, 2000) from the Deputy Clerk, Town of Tecumseh, advising that the Council of the Town of Tecumseh at its meeting of October 10, 2000, passed the following resolution:

"That the Council of the Town of Tecumseh support the September 25, 2000 Resolution No. M83-2000 passed by the Council of the City of Windsor respecting truck traffic associated with the City of Toronto's waste disposal to Michigan";

and forwarding a copy of the City of Windsor's resolution, wherein it is resolved, in part, that:

- (1) the City of Windsor express its strong concern about the truck traffic associated with the disposal of Toronto's waste to Michigan; and
- (2) the City of Windsor request that the City of Toronto maximize the use of rail options, such as the new CP Rail Service, in order to minimize or eliminate the consequences associated with the trucking option; and
- (3) the Mayor and City Council solicit support for the rail proposal from other mayors and councils along the 401 corridor; and
- (4) the City of Windsor administration contact CP Rail in order to develop further arguments and refinement for this proposal including other modes of transportation such as barge transport along the Great Lakes and, if the Republic Landfill Site is chosen, to consult with all affected communities along the 401 corridor;
- (ii) (October 25, 2000) from the Deputy Clerk, County of Elgin, advising that the Council of the Corporation of the County of Elgin at its meeting on October 24, 2000, passed the following resolution:

"That the Council of the County of Elgin supports the resolution from the City of Windsor concerning the negative environmental consequences the transfer of waste materials to the Republic Landfill Site in Detroit, Michigan, by truck will have on communities directly abutting the Highway 401; and

That the City of Toronto be requested to maximize the use of rail options for the transport and disposal of their municipal waste to the Republic Landfill Site to minimize or eliminate the consequences associated with the trucking option";

(iii) (October 30, 2000) from the Director, Council and Administrative Services/Regional Clerk, Region of Waterloo, advising that the Council of the Regional Municipality of Waterloo at its meeting of October 25, 2000, approved a resolution respecting the City of Toronto's garbage disposal, wherein it is resolved:

"That the Region of Waterloo express its strong concern about the truck traffic associated with the disposal of Toronto's waste to Michigan; and

That the Region of Waterloo request that the City of Toronto maximize the use of rail options, such as the new CP Rail Service, in order to minimize or eliminate the consequences associated with the trucking option";

- (iv) (November 6, 2000) from the Deputy City Clerk, City of Sarnia, advising that the Council of the City of Sarnia at it meeting of October 30, 2000, adopted a resolution respecting the transportation of waste by the City of Toronto to the State of Michigan, wherein it is resolved, in part, that:
  - (1) the City of Sarnia supports the City of Windsor's resolution in asking for a full environmental assessment to address what the impact of both truck and rail options would have on air quality along with other impacts; and
  - (2) the City of Toronto be requested to undertake an examination of all potential avenues and methods for the disposal and transportation of its garbage, including the disposal of garbage within the Greater Toronto Area;
- (v) (November 17, 2000) from the City Clerk, City of Woodstock, advising that the Council of the City of Woodstock at its meeting of November 2, 2000, passed a resolution, wherein it is resolved that the City of Woodstock advise the Province, the City of Toronto and the M.P.P. for Oxford, Ernie Hardeman, of the City's opposition to the trucking of waste;
- (vi) (February 2, 2001) from Councillor Betty Disero, Chair, Works Committee, addressed to Mr. Gordon E. McGuinty, Notre Development, with respect to the motion adopted by Council at its meeting on January 31, 2001, regarding the Adams Mine site; and advising that the Committee cannot hear any deputations with respect to this matter;

- (vii) (February 5, 2001) from Mayor Michael D. Hurst, City of Windsor, addressed to Mayor Anne Marie DeCicco, City of London, in support of her initiative and leadership on this issue; advising that he would be unable to attend the meeting of the Works Committee; and outlining the role of the Province of Ontario and the Ministry of the Environment with respect to waste management issues;
- (viii) (February 6, 2001) from Mayor Mike Bradley, Mayor of Sarnia, addressed to Mayor Anne Marie DeCicco, City of London, expressing his regret at being unable to attend the meeting of the Works Committee, and providing his support for the action being taken;
- (ix) (February 6, 2001) from Mr. Gary M. Sosnoski, City Clerk, City of Kitchener, advising that the City of Kitchener adopted a resolution at a special meeting held on February 5, 2001, wherein it is resolved that Kitchener City Council wishes to go on record as being opposed to the disposal of municipal waste outside of a municipal jurisdiction and the Province of Ontario; and specifically, to the shipping of waste by truck from Toronto to Michigan along Highway 401; and
- (x) (February 6, 2001) from Mr. David E. Bonior, Member of Congress of the United States, House of Representatives, in opposition to the out-of-state and out-of-country waste being shipped to Michigan.

(1) the Chairs of the Waste Diversion 2010 Task Force, in consultation with any other interested Members of Council, be requested to establish a 401/402 Corridor consultation process involving the Southwestern Ontario Trash Coalition, such process to be developed in consultation with interested parties including those from Michigan;

- (2) the Mayor make arrangements for the City to respond promptly to the questions raised by the members of the neighbouring communities, and such responses be presented to the consultation process;
- (3) the Commissioner of Works and Emergency Services be requested to examine the CP Rail Expressway option for the shipment of all or part of the City's waste, in consultation with neighbouring communities, the consultation process established, the contractors, Republic Services and Wilson Logistics, and CP Rail;
- (4) the Ministry of the Environment be advised that the City will co-operate fully with any review of the City's waste management system;
- (5) the City adopt a full disclosure policy with respect to the waste transportation to Michigan, and share any information with interested parties; and
- (6) the Commissioner of Works and Emergency Services be requested to develop a strategy for removing any toxics from the waste stream that might otherwise bring the City into conflict with health standards in Michigan, or emerging health standards, that could have an impact on waste being shipped to Michigan.

# 3.6 Enwave Anaerobic Digestion Facility – Responses to Information Requests; Former City of Toronto Incineration By-laws.

The Works Committee had before it a report (January 19, 2001) from the Commissioner of Works and Emergency Services responding to the Committee's requests at its last meeting for information on the planning process for the siting of an anaerobic digestion facility on City-owned property to process municipal waste to generate biogas for the district energy needs of the downtown core; forwarding a copy of the application to the Federation of Canadian Municipalities' Green Municipal Enabling Fund, as requested; advising that Acres International has been retained by Enwave to conduct a feasibility study in advance of the FCM funded feasibility study on anaerobic digestion, and that Works and Emergency Services was not involved in the hiring of Acres International or the establishment of the terms of reference under which Acres International is conducting the study; noting that Enwave has advised that Acres International is conducting an environmental and economic audit of waste to energy technologies, which includes incineration of solid waste among other technologies being reviewed, but that the focus continues to be the potential of utilizing anaerobic digestion technology; further advising that the potential for including additional sewage sludge digestion as part of the anaerobic investigation will be incorporated into the terms of reference for Part II of the feasibility study, if funding is successfully attained from the Green Municipal Enabling Fund; noting that Enwave will liase with the Medical Officer of Health concerning the results of the Phase I feasibility study; and recommending that this report be received for information.

The Committee also had before it a report (January 15, 2001) from the Commissioner of Works and Emergency Services advising that the existing Municipal Code for the former City of Toronto includes a set of by-laws intended to prohibit incineration within the boundaries of the former City, and providing an update on the current status of the former City of Toronto incineration by-laws; further advising that in anticipation of the City's by-law harmonization process, Works and Emergency Services and the Legal Services Division have conducted an initial review of the former City of Toronto Municipal Code and Zoning by-laws that prohibit incineration within the former City of Toronto; that such Municipal Code by-laws remain in effect within the former City of Toronto geographic boundaries, and that the Zoning by-laws remain under appeal; that the environmental significance of these by-laws requires that City staff develop a process to complete the review of the by-laws and identify options for the City in the context of Municipal Code harmonization, which process will include consultation with affected agencies, stakeholders and the public; and that completion of this process will enable the City to advise the Ontario Municipal Board of its decision regarding the outstanding appeal; and recommending that this report be received for information.

The Committee also had before it a communication (January 23, 2001) from Dr. Juri Pill, President and Chief Executive Officer, Enwave District Energy Limited, respecting the request of the Committee at its last meeting to bring forward the terms of reference for the feasibility study of anaerobic digestion that Acres International is carrying out for Enwave; providing background with respect to Enwave's objective to find an alternate fuel source to natural gas, and noting that one of the most promising options seems to be energy from waste, specifically anaerobic digestion; advising that due to the compressed deadline approved by Council for a feasibility study of an anaerobic digestor plant, it was agreed that Enwave would commission and carry out a first phase of the feasibility study on its own, which has been done with Acres International being retained to undertake the study; and further advising that the terms of reference for the study consisted of answering three questions as outlined therein.

The Committee received the aforementioned reports and communication.

# 3.7 Harmonization of Waste Management Services for Multi-Unit Residential Buildings where the City Provides Collection Services.

The Works Committee had before it a report (January 26, 2001) from the Commissioner of Works and Emergency Services recommending that:

- (1) property owners or managers of multi-unit residential buildings be required to purchase the necessary waste collection containers for their buildings and that these containers meet the specifications as determined by the City;
- (2) the waste container rental fee program in the Toronto Community be terminated, effective January 1, 2002, and the current bulk waste containers being used in this program be provided at no charge to the property owners or managers of the associated buildings,

provided the containers have been rented for more than five years, or at a fee per container proportional to the period each container has been rented for those containers rented for less than five years;

- (3) effective January 1, 2002, Solid Waste Management Services be authorized to purchase and supply recycling containers, at no charge to the property owner or manager, to those multi-unit residential buildings where the City provides waste collection services at an estimated annual cost of \$260,000.00;
- (4) property owners or managers be responsible for the cost of replacing lost, stolen or damaged recycling containers other than in those instances where the City is responsible for the damage, in which case the City would be responsible for replacing or repairing the containers;
- (5) blue tote bags for residents to carry their recyclables from their unit to the recycling collection containers be made available to all residents of multi-unit residential buildings at a cost of \$5.00 per bag, and that property managers and owners of new multi-unit residential developments be given the option of purchasing these tote bags for all of their units at a cost of \$5.00 per bag; and
- (6) the Commissioner of Works and Emergency Services be authorized to consult with property managers and owners on the service fee options discussed in this report and report back to the Works Committee with recommendations.

The Committee also had before it the following:

- (i) communication (February 5, 2001) from Mr. Brad Butt, Executive Director, Greater Toronto Apartment Association, requesting that staff conduct a consultation with the Greater Toronto Apartment Association as part of their review of the options contained in the report; and
- (ii) copy of New York City's "Superintendent's Recycling Handbook", submitted by Councillor Jane Pitfield.

Councillor Balkissoon moved that the Committee recommend to the Policy and Finance Committee the adoption of the aforementioned report, subject to consideration of Recommendation No. (2) being deferred pending the further report to be submitted to the Works Committee on service fee options for multi-unit residential buildings. (**Carried**)

Councillor Pitfield moved that:

- (1) the Province of Ontario be requested to enforce existing legislation with respect to mandatory recycling in multi-unit residential buildings; and
- (2) the Commissioner of Works and Emergency Services be requested to:
  - (i) investigate New York City's "Superintendent's Recycling Handbook" for consideration as a possible initiative for the City of Toronto; and
  - (ii) submit a report to the Works Committee on means of encouraging source separation in each multi-unit residential building.

## 3.8 Year-Round Once-A-Week Curbside Collection of Recyclable Materials and Weekly Summertime Collection of Yard Waste.

- (1) consideration be given in the 2001 Operating Budget review to:
  - (i) implementing once-a-week curbside collection of recyclable materials in the North York Community and the west section of the Toronto Community on July 2, 2001, at a 2001 Operating Budget cost of \$245,000.00;
  - (ii) implementing once-a-week curbside collection of recyclable materials in all the remaining parts of the City on July 2, 2002, at a 2002 Operating Budget cost of \$1,525,000.00; and

- (iii) implementing weekly summertime collection of yard waste across the entire City commencing June 1, 2001, at an Operating Budget cost of \$433,500.00; and
- (2) the above recommendations be subject to:
  - (i) discontinuing the roll-out of twice-a-week summer curbside garbage collection across the City in 2001; and
  - (ii) deleting twice-a-week summer curbside garbage collection in those areas where it was provided in 2000, with those areas being the first to receive once-a-week curbside collection of recyclable materials.

Councillor Douglas Holyday, Ward 3 - Etobicoke Centre, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Balkissoon, the Committee recommended to the Budget Advisory Committee that the aforementioned report be received.

- (2) the following booking procedures be approved for the year 2001 Environment Days:
  - (a) the number of Environment Days to be held in 2001 be limited to 44, one per ward;

- (b) the Commissioner of Works and Emergency Services be authorized to choose the date and location and host the Environment Days in any ward where the Councillor has not selected a date by March 28, 2001;
- no changes be made to dates and locations for the Environment Days after they have been publicized, unless deemed absolutely necessary by the Commissioner of Works and Emergency Services;
- (d) events be held on Thursdays and Saturdays only;
- (e) not more than two events in different wards be held on the same Saturday; and
- (f) events be booked on a faxed first-come, first-served basis, commencing at 8:00 a.m. on Tuesday, March 13, 2001, if this report is approved by Council by Thursday, March 8, 2001; and
- (3) for 2001 Environment Days:
  - (a) blue and grey boxes only be distributed free of charge to residents who bring back a damaged box for replacement or to new residents;
  - (b) distribution of finished compost be limited to one truckload per event; and
  - (c) separate truckload sales of composters be discontinued.

The Committee also had before it a communication (February 5, 2001) from Councillor Howard Moscoe, Ward 15 - Eglinton-Lawrence, requesting that the policy for Environment Days be amended to permit at least one or two events to be held on a Sunday, to permit observation of the Jewish Sabbath on Saturday and still allow for events on weekends.

Councillor Layton moved that the Committee recommend to the Policy and Finance Committee the adoption of the aforementioned report, subject to the following:

- (i) amending Recommendation No. (2)(d) by adding thereto the words "and Sundays", so that such Recommendation reads as follows:
  - "(d) events be held on Thursdays, Saturdays and Sundays only;"

- (ii) amending Recommendation No. (2)(e) by deleting the word "Saturday" and inserting in lieu thereof the word "weekend", so that such Recommendation reads as follows:
  - "(e) not more than two events in different wards be held on the same weekend;" and
- (iii) deleting Recommendation No. (3)(a).

Councillor Pitfield moved that the foregoing motion by Councillor Layton be amended to provide that Councillors be given the opportunity of hosting joint Environment Days where they so wish, for example, two Councillors in one federal riding. (**Carried**)

the lowest tender received for these operations combined, based on weekly collection, at total annual estimated amount of \$1,810,979.28, including all charges and taxes;

- (2) authority be granted to retender the contract for the curbside collection of recyclable materials, on an hourly basis, in District 1, York Community, and to report back to Council with the new bid prices for this service at a later date; and
- (3) the appropriate officials be authorized and directed to take the necessary actions to give effect thereto.

The Committee also had before it a communication (February 7, 2001) from Mr. Brian Cochrane, President, Toronto Civic Employees' Union - CUPE Local 416, recommending that the Committee reject Recommendation No. (2) of the report dated January 24, 2001, from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer, and alternatively provide direction that the curbside recycling component for District 1, York Community, be done by municipal forces.

The Committee deferred consideration of the aforementioned joint report until its special meeting scheduled to be held on February 21, 2001.

- (v) the feasibility of alternative methods of collection of recyclables in apartment buildings, such as door-to-door collection;
- (vi) costs of mandatory recycling in apartment buildings; and
- (vii) availability of cost information for City Councillors regarding the City's waste management system including information from consultants regarding projected costs for various waste diversion scenarios and on the costs of the City's waste collection system;

and recommending that this report be received for information.

The Committee also had before it the following communications:

The Committee also had before it a communication (February 7, 2001) from Mr. Brian Cochrane, President, Toronto Civic Employees' Union - CUPE Local 416, in support of the proposed pilots for diversion, including the system similar to Local 416/Toronto Environmental Alliance's proposed wet/dry plan; advising that Local 416 is encouraged at the projects being conducted with municipal forces and the commitment to involve the Union in the implementation and results analysis of the projects; and outlining a number of areas in which ongoing discussions will be necessary.

# 3.15 Computer Recycling Depots at Transfer Stations.

number being resold at fair market price to the general public; noting that TLA has committed to conduct a media launch on the depots' opening day, March 28, 2001; further advising that computers will only be accepted from residents at the depots; and recommending that this report be received for information.

## 3.16 Comparison of Curbside Waste Collection Costs.

The Works Committee had before it a report (January 22, 2001) from the Commissioner of Works and Emergency Services providing a comparison of curbside waste collection costs from 1997 to 2000, for residential and commercial waste, and highlighting achievements and improvements as a result of amalgamation; discussing options for improving future costs, including (a) changing the collection schedule from 5 days per week/8 hours per day to 4 hours per week/10 hours per day, (b) elimination of twice-per-week waste collection in the summer, and (c) modifications to the commercial collection system; concluding that based on the analysis presented in this report, the cost of providing curbside waste collection by City staff has decreased since amalgamation while the cost of contracted services is rising, and that implementation of new initiatives in non-contracted areas of the City will continue to close the gap between in-house and contracted costs; and recommending that this report be received for information.

## 3.22 No-Fault Flood Grant Program: Basement Flooding Damages and Clean-Up Costs.

The Committee at its meeting on February 7, 2001, had before it a joint report (January 24, 2001) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) a City-wide Basement Flood Grant Program not be established for flooded basements, as it would not provide any beneficial effects for the City, the cost of the program is unpredictable and potentially excessive, and the program is not required under the *Municipal Act*;
- (2) Resolution No. 91-21 of the former North York City Council be repealed, being a public No-Fault Grant program which provides financial assistance to former City of North York residents for damages caused by sewer back-ups and water main breaks;
- (3) should the Committee wish to implement a City-wide Basement Flood Grant Program, such program shall be in the amount of \$500 or \$1,000 or \$1,500 per flooding incident; the approximate cost to the City, based on a typical year of 1,030 occurrences, is estimated to be \$515,000, \$1,030,000 or \$1,545,000 annually;
- (4) should Committee adopt Recommendation No. (3) of this report, the following be approved:
  - (i) an additional annual provision of \$500,000 or \$1,000,000 or \$1,500,000, depending on the grant limit chosen, be credited to the Basement Flood Grant Reserve Fund to stabilize the Reserve Fund in the event of an extraordinary storm;
  - (ii) the administrative guidelines as set out in Appendix "A" of this report will apply;

- (iii) the Chief Financial Officer and Treasurer report back on the creation of the Basement Flood Grant Reserve Fund By-law and funding plan for the Program as part of the rate setting report for the 2001 water rate;
- (iv) two additional clerical positions be created to administer the Basement Flood Grant program, at an estimated annual expense of \$100,000 plus related expenses;
- (v) funding for Recommendations Nos. (4)(i) and (iv) be provided from the Water and Wastewater Reserves and that the Water Rate be adjusted accordingly; and
- (vi) the existing North York No-Fault Flood Grant program remain in place until such time as a City-wide Basement Flood Grant program is implemented as part of the 2001 budget process; and
- (5) staff be directed to give effect to the foregoing.

The Committee also had before it a communication (February 5, 2001) from Councillor Howard Moscoe, Ward 15 - Eglinton-Lawrence, respecting the repeal of the public No-Fault Grant Program of the former City of North York; and recommending that Recommendation No. (2) of the staff report be amended by adding thereto the words "at such time as the sewers in flood prone areas have been repaired".

Councillor John Filion, Ward 23 – Willowdale, appeared before the Committee in connection with the foregoing matter.

Councillor Pitfield moved the adoption of Recommendations Nos. (1), (2) and (5) embodied in the aforementioned report. (**Redundant**)

The Committee deferred consideration of the aforementioned report and communication until its special meeting scheduled to be held on February 21, 2001.

The Committee also had before it a report (January 25, 2001) from the Commissioner of Works and Emergency Services advising, in response to concerns raised by the citizen members of the Storm Water Group with respect to the disbanding of the Group, that the City is developing a Wet Weather Flow Management Master Plan to formulate strategies for the prevention, control and reduction of wet weather flow impacts across the City, and that the role of the Storm Water Group with respect to identifying areas of the City where implementation of non-structural programs to address stormwater and/or combined sewer overflow needs are feasible, has therefore been superseded by the WWFMMP Steering Committee; further advising that the Ellis Avenue and Colborne Lodge Drive storm outfalls study is nearing completion, with the draft Environmental Study Report scheduled to be circulated to the Steering Committee and the Storm Water Group members for review and comments; noting that once such Environmental Study Report is finalized and circulated for the mandatory 30-day review, the conditions pertaining to the Storm Water Group in the Exemption Order for the Western Beaches Tunnel will have been fulfilled and the Storm Water Group can be disbanded; and recommending that this report be received for information.

Councillor Disero appointed Councillor Pitfield Acting Chair, and vacated the Chair.

On motion by Councillor Disero, the Committee recommended to Council that the Storm Water Group be disbanded.

The polyelectrolyte submitted by Canada Flocculants Incorporated, product designation HF-232-T at \$4,020.00 per tonne, excluding all taxes;

Highland Creek Treatment Plant:

The polyelectrolyte submitted by Canada Flocculants Incorporated, product designation HF-141-T at \$3,990.00 per tonne, excluding all taxes;
