Confirmation of Minutes

On motion by Councillor Walker, the Minutes of the meeting of the Community Services Committee held on May 1, 2003, were confirmed.

5.1 Presentation on the Toronto Heavy Urban Search and Rescue Team

The Committee had before it a joint report (May 15, 2003) from the Commissioner of Works and Emergency Services and the Fire Chief and General Manager providing a review and update on the function of the Toronto Heavy Urban Search and Rescue team at major emergencies; and recommending that the report be received for information.

The Fire Chief and General Manager provided the Community Services Committee with a power point presentation on the Heavy Urban Search and Rescue Team; the role the Team played at the fire and explosion at 3885-3887 Bloor Street West on April 24, 2003, which destroyed the commercial/residential building; the equipment used to lift and move, breach and shore heavy objects and structural components; and on the training undertaken by the Team.

The Fire Chief demonstrated how the Thermal Imaging Camera and Search Cam are used in rescue operations; and introduced the following members of the Team:

- Captain L. Thomas, Toronto Fire Service;
- Mr. Alan Wingfield, Toronto EMS;
- Staff Sergeant Bill Neadles, Toronto Police Service; and
- Mr. Don Sorel, Works and Emergency Services Department.

The Committee:

- (1) received the aforementioned report and presentation; and

- (2) directed that the Commissioner of Works and Emergency Services and Fire Chief and General Manager be requested to submit a report to the Community Services Committee on a mechanism (Memorandum of Understanding, etc.) to develop a mutual aid system, such system to be available for disasters that are on a national level, and where the Heavy Urban Search and Rescue Team may be helpful; and further that the report include a financial breakdown of the cost-sharing percentages with the provincial and federal governments.

5.2 Toronto EMS Emergency Sole Source Purchases Related to SARS

The Committee had before it a revised report (May 29, 2003) from the Commissioner of Works and Emergency Services advising of a SARS-related emergency sole source purchase on April 9, 2003, of protective medical equipment and supplies from Source Medical in the amount of \$1 million; and recommending that:

- (1) Council be aware that an emergency purchase of \$1 million gross and zero net in material purchases was authorized by the Commissioner of Works and Emergency Services in response to the SARS outbreak;
- (2) the Commissioner of Works and Emergency Services report back as part of the 2003 Operating Budget 2nd Quarter Variance Report confirming receipt of the one-time Provincial funding of \$1 million for this SARS related item;
- (3) the technical adjustment for this unbudgeted item be conducted as part of the corporate adjustment being made for the SARS expenditures identified in the May 15, 2003, report reviewed by Council at its meeting of May 21, 22, and 23, 2003; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Walker, the Committee recommended to Council the adoption of the aforementioned report.

5.3 2003 Service Cut and Revised Spending Strategy for Child Care Resulting from Provincial Underfunding

The Committee had before it the following report and communications:

- (May 21, 2003) from the Commissioner of Community and Neighbourhood Services confirming the 2003 provincial funding contribution to child care and proposing a service cut and revised spending strategy for child care that provides optimal use of committed City resources and respects historic commitments made to the community; and recommending that:
 - (1) the City's Child Care Campaign to keep licensed child care on the public agenda and to press the provincial government to pay its fair share of the costs be sustained;
 - (2) as a result of the provincial failure to provide sufficient funding for the child care system within Toronto, the City reduce its subsidy space ceiling by approximately 500 spaces through naturally occurring client turnover and in accordance with the equity provisions of the Child Care Service Plan;
 - (3) the City's portion of this year's instalment on the phased return to the payment of child care operators' actual costs approved in the 2003 operating budget, (\$666.7 thousand) be paid in an equitable manner to child care programs under contract with the City;
 - (4) at calendar year end, any underexpenditure of the City's portion of the approved 2003 Children's Services budget be reallocated to provide one-time minor capital funding for unmet health and safety needs in child care programs under contract with the City;
 - (5) the Department report at the next Community Services Committee meeting on a process to prepare a new five-year Service Plan for Child Care that will address key policy issues confronting child care including the payment of actual costs, sustaining subsidized service levels, improving the equity of access to licensed care and developing an integrated approach to managing the child care service system within Toronto; and
 - (6) the appropriate City officials take the necessary action to give effect thereto;

- (May 30, 2003) from the City Clerk advising that the Children and Youth Action Committee on May 27, 2003, during consideration of a report (May 21, 2003) from the Commissioner of Community and Neighbourhood Services, headed “2003 Service Cut and Revised Spending Strategy for Child Care Resulting from Provincial Underfunding”, recommended that the following motion by Ms. Fiona Nelson be adopted:

**5.6 Construction of a Child Care Centre at 610 Jane Street -
Tender No. 54-2003 (Ward 13 - Parkdale-High Park)**

The Committee had before it a revised joint report (May 21, 2003) from the Commissioner of Community and Neighbourhood Services and Chief Financial Officer and Treasurer recommending that:

- (1) the total capital budget for the construction of a Child Care Centre at 610 Jane Street be increased by \$180,000.00 to \$1,130,000.00 and that the necessary amount be funded from the Child Care Capital Reserve Fund;
- (2) Tender No. 54-2003 for the Construction of the Child Care Centre at 610 Jane Street, be awarded to Brown Daniels & Associates in the amount of \$952,670.00 including all taxes and charges, being the lowest acceptable tender received; and
- (3) the appropriate City officials take the necessary action to give effect thereto.

**5.7 Occupancy Cost Agreements for Child Care Between the
City and the Toronto District School Board and the
Conseil Scolaire de District Catholique Centre-Sud**

The Committee had before it a report (May 12, 2003) from the Commissioner of Community and Neighbourhood Services seeking approval to amend the current agreement between the City and the Toronto District School Board, and to enter into an agreement with the Conseil Scolaire de District Catholique Centre-Sud for the payment of occupancy costs for child care programs located in their facilities; and recommending that:

- (1) the City make remittances to the Conseil Scolaire de District Catholique Centre-Sud at a rate of \$10.00 per month per child under the age of 3.8 enrolled in licensed child care spaces operated in their facilities;
- (2) payments to the Conseil Scolaire de District Catholique Centre-Sud be made using an appropriate transfer mechanism as determined by the Commissioner of

- Community and Neighbourhood Services, in consultation with the Chief Financial Officer and Treasurer and the City Solicitor;
- (3) the City make remittances to the Toronto District School Board at the rate of \$6.50 per square foot for exclusive space used to provide child care services effective January 1, 2003;
 - (4) actual payments be tied to approved square footage in accordance with the Child Care Service Plan; and
 - (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mihevc, the Committee recommended to Council the adoption of the aforementioned report.

5.8 Dissemination of Information to Parents Regarding the Child Tax Benefit and National Child Benefits Supplement

The Committee had before it a report (May 10, 2003) from the Commissioner of Community and Neighbourhood Services responding to a recommendation of the Children and Youth Action Committee from its meeting on April 24, 2002, regarding the dissemination of information to parents regarding the Child Tax Benefit and the National Child Benefit Supplement; and recommending that:

- (1) starting in September 2003, for a three-month trial period, individual postcards with appropriate, brief information regarding the Child Tax Benefit and National Child Benefit Supplement (CTB and NCBS), in languages consistent with the City's multilingual policy and with instructions to call 211 for further information, be distributed to child care centres, recreation centres, libraries, neighbourhood centres, settlement houses, family shelters and public health programs in sufficient numbers to distribute to parents;
- (2) funding for the postcards not exceed \$2,500.00 and be allocated from the budget of the Children and Youth Action Committee and that the Community Information Toronto 211 call centre resource the trial period from existing resources;
- (3) if the trial period indicates that additional resources are necessary to continue the initiative, staff include the appropriate request in the 2004 budget submission; and

- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

 - (b) report to the Community Services Committee on how the proposed \$66,500.00 in research costs to review community social planning in Toronto will be used.

Councillor Shaw moved that part (iii) of the foregoing motion by Councillor Mihevc be amended to provide that the Commissioner of Community and Neighbourhood Services be requested to include in the report a mechanism to include new groups in the entire grants process.

The Chair appointed Councillor Mihevc Acting Chair and vacated the Chair.

- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
