The Toronto partnership has successfully leveraged partnership involvement from over 150 community agencies and individuals, and almost \$10 million in in-kind resources. Phase II of the provincial heart health initiative was confirmed with the renewal of Ministry funding in the amount of \$2.8 million for an additional 5 years (April 2003 to March 2008). [Minute No. 4.9 refers to the report.]

The Chair, on behalf of the Board, also recognized and commended Dr. Sheela Basrur, the Medical Officer of Health, and Toronto Public Health staff for their outstanding performance during the recent SARS outbreak and presented a plaque to the Medical Officer of Health honouring the teamwork of the Health Unit. The Board also gave a standing ovation.

4.1 Children's Mental Health

The Board of Health had before it a report (April 28, 2003) from the Medical Officer of Health presenting the results of a needs assessment and literature review regarding the mental health of young children in Toronto, initiated by the Children and Youth Action Committee and Toronto Public Health; and recommending that:

- (1) the Board of Health commend the Children and Youth Action committee for identifying children's mental health as a significant issue requiring further attention and for providing the funding to complete the report entitled "Improving the Mental Health of Young Children in Toronto: Needs Assessment and Literature Review";
- (2) this report be forwarded to the Children and Youth Action Committee for its consideration;
- (3) Toronto Public Health collaborate with Children's Services Division, Community and Neighbourhood Services Department, and other relevant City services to

prepare a joint follow-up report on an implementation plan and implications of the "Improving the Mental Health of Young Children in Toronto: Needs Assessment and Literature Review" report; and

(4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The following persons appeared before the Board of Health in connection with the foregoing matter:

On motion by Councillor David Socknacki, the Board of Health adopted the foregoing report and, further, requested Toronto Public Health and Children's Services Division staff, when drafting recommendations for the follow up report outlined in Recommendation No. (3) to:

- (a) consider the establishment and measurement of success indicators; and
- (b) prioritize the recommendations which require City resources.

4.2 Healthy Babies, Healthy Children Evaluation

The Board of Health had before it a report (April 28, 2003) from the Medical Officer of Health providing an overview of the provincial program evaluation that was conducted by the Integrated Services for Children Division of the Ministry of Health and Long Term Care on the Healthy Babies Healthy Children program; and recommending that:

- (1) the Board of Health acknowledge the Ministry of Health and Long Term Care's commitment to supporting local Healthy Babies Healthy Children programs by co-ordinating and funding both the Integrated Services for Children Information System (ISCIS) database and the program evaluation;
- (2) the Board of Health advocate to the Ministry of Health and Long Term Care for funding levels that fully support the delivery of the Healthy Babies Healthy Children in accordance with provincial program standards; and

(3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Ron Robinson, President, Applied Research Consultants, gave an overhead slide presentation.

On motion by Coucillor Pitfield, the Board of Health adopted the foregoing report, as amended, by amending Recommendation No. (2) to read:

"(2) the Chair of the Board of Health and the Mayor be requested to advocate to the Ministry of Health and Long Term Care in a letter to fully fund the Healthy Babies, Healthy Children program at a level that supports program delivery in accordance with Ministry standards and guidelines;"

4.3 Sole Source Contract for Interpretation Services with Access Alliance Multicultural Community Health Centre

The Board of Health had before it a report report (April 28, 2003) from the Medical Officer of Health requesting authority to extend the sole source contract with Access Alliance Multicultural Community Health Centre for the provision of interpretation services required to deliver Toronto Public Health services to the City's multicultural community; and recommending that:

- (1) concurrence be given for 2001/02 expenditures through Access Alliance Multicultural Community Health Centre for the purchase of additional cultural interpretation services to support the delivery of Toronto Public Health programs, in the amount of \$784,700.00;
- (2) the sole source contract with Access Alliance Multicultural Community Health Centre for the purchase of cultural interpretation services be extended from January 1 to July 31, 2003 in the amount of \$350,000.00 with the understanding that a Request for Proposals has been initiated in order to establish a new purchase of service contract; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board also had before it a communication (May 6, 2003) from the Board of Health Budget Subcommittee.

On motion by Coucillor Pitfield, the Board of Health recommend to Council the adoption of the foregoing report.

4.4 2003/2004 Student Nutrition Program Service Subsidies

The Board of Health had before it a report (May 6, 2003) from the Medical Officer of Health recommending that:

- (1) the Board of Health recommend that City Council execute agreements totalling \$1,999,340.00 with the Toronto Foundation for Student Success (\$1,795,057.02) and the Metropolitan Toronto Catholic Education Foundation (\$204,282.98) to administer the allocation of service subsidies to eligible student nutrition programs across the City of Toronto;
- (2) authority be granted to the Medical Officer of Health to take the necessary action to give effect thereto, including the execution of agreements with the Toronto Foundation for Student Success and the Metropolitan Toronto Catholic Education Foundation on behalf of the City; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Mihevc appointed Mr. Zaslofsky Acting Chair, and vacated the Chair.

On motion by Counicllor Mihevc, the Board of Health recommended to the Policy and Finance Committee and Council adoption of the foregoing report and, further, requested the Medical Officer of Health to report to the Board, prior to the 2004 Budget process, on the level of funding necessary to meet the need and a strategy to achieve such funding.

Coucillor Mihevc resumed the Chair.

4.5 Reduction of the Toronto Public Health 2003 Operating Budget

The Board of Health had before it a report (April 25, 2003) from the Medical Officer of Health seeking approval for a technical amendment to the Toronto Public Health 2003 Operating Budget; and recommending that:

- (1) the Board of Health forward this report to the Policy and Finance Committee for approval of a reduction of the Toronto Public Health 2003 Operating budget in the amount of \$985,842 gross, \$0 net; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board also had before it a communication (May 6, 2003) from the Board of Health Budget Subcommittee.

On motion by Mr. Hyndman, the Board of Health recommended to the Policy and Finance Committee and Council that Toronto Public Health and City Council continue to maintain the Healthy Babies Healthy Children program at the current staffing and service levels.

4.6 Harm Reduction Programs Targeting Drug Users in the City of Toronto

The Board of Health had before it a report (April 28, 2003) from the Medical Officer of Health outlining the various harm reduction programs in the City of Toronto that target drug users; and recommending that:

- (1) the Board of Health endorse this report and forward it to the Community Services Committee;
- (2) the Medical Officer of Health and the Commissioner of Community and Neighbourhood Services report back to the Board of Health and Community Services Committee on a process, including possible sources of funding, to initiate a municipal drug framework and strategy for the City of Toronto based on the four pillars of prevention, treatment, enforcement, and harm reduction; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

In summary, the Board of Health adopted the foregoing report, as amended, by adding the following:

"It is further recommended that:

- the Medical Officer of Health be requested to consult with the Toronto Police Service during the development of the municipal drug framework and strategy; and
- (ii) the final report include comment on the amount of funds spent by the City on drug-related initiatives and the number of programs through which the funds are being diffused at present and to include the estimated amounts of funding for each of the four pillars of prevention, treatment, enforcement, and harm reduction."

4.7 AIDS and Drug Prevention Funding to Street Health Community Nursing Foundation

4.8 Update on Regulatory Changes at Health Canada Related to Food and Nutrition

The Board of Health had before it a report (April 28, 2003) from the Medical Officer of Health informing the Board of Health about recent regulatory changes at Health Canada related to food and nutrition; and recommending that:

- (1) the Board of Health communicate its support to the Federal Minister of Health for the new nutrition labeling policy announced by Health Canada in January 2003;
- (2) the Board of Health recommend to Health Canada that they adopt the following recommendations regarding health claims and food fortification:
 - (a) allow sufficient time to monitor the impact of generic health claims on purchasing patterns, dietary practices and population health outcomes before approving product-specific health claim regulations;
 - (b) ensure that fortification is based on sound nutrition rationale and targets nutrients of identified public health significance;
 - (c) demand evidence that the nutritional health of Canadians will be improved with fortification; and
 - (d) continue to take a leadership role in consumer education and devote resources towards consumer education campaigns relating to fortified foods.

- (3) the Board of Health re-affirm to Health Canada the need for an effective and sustainable national nutrition surveillance system with accurate nutrition methodology; and
- (4) the appropriate City officials be authorized and directed to take necessary action to give effect thereto.

On motion by Mr. MacKay, the Board of Health adopted the foregoing report and, further, directed that a copy of the report be forwarded to the Ontario Public Health Association and the Association of Local Public Health Agencies for information.
