Remuneration and Expenses of Members of Council and of the Council Appointees to Local Boards and Other Special Purpose Bodies for the year ended December 31, 2005

City Council on July 25, 26 and 27, 2006, amended this Clause by adding the following:

"That:

- (1) the Treasurer be requested to amend Table 1 and Appendix B to the report (April 18, 2006) from the Treasurer to include, for the permanent record, a footnote to Councillor Shiner's account for photocopying charges;
- (2) Councillor Holyday and Councillor Ford be requested to reimburse the City retroactively, to their Constituency Budgets or their Global Office Budget, for their office use; and
- (3) the City Clerk be requested to report on a policy for touchdown spaces at Civic Centres."

This Clause, as amended, was adopted by City Council.

Council also considered additional material, which is noted at the end of this Clause.

City Council on June 27, 28 and 29, 2006, postponed consideration of this Clause to its next regular meeting on July 25, 2006.

The Administration Committee recommends that City Council request the Internal Auditor to review the Councillors' office expenses and the reasons for the wide range of amounts expended and report back to the Administration Committee with any recommendations.

Action taken by the Committee:

The Administration Committee:

- (1) requested the Treasurer to report directly to Council on action the Treasurer could take with respect to noting Councillor Shiner's concerns about photocopying expenses;
- (2) requested the Internal Auditor to investigate the unauthorized use of photocopiers on the Councillors' floor to ascertain that charges for copies are charged correctly to Councillors' accounts;
- (3) requested the City Clerk, in consultation with the Treasurer, to report to the May 2, 2006 meeting of the Administration Committee on 2005 actual expenses incurred from City resources to pay for expenses towards any conference, convention, etc. that may or may not have been attended by a Member of Council or staff; and
- (4) requested the City Clerk to report on whether the policy with respect to travel expenses for staff and Councillors whereby they are required to submit receipts and a detailed report on the conference they have attended, is being complied with.

The Administration Committee submits the report (February 27, 2006) from the Treasurer.

Purpose:

To report, in accordance with Section No. 284 of the Municipal Act (S.O. 2001), on the remuneration and expenses of Members of Council and of the Council Appointees to Local Boards and other Special Purpose Bodies for the year ended December 31, 2005.

Financial Implications and Impact Statement:

There are no financial implications arising from this report

Recommendations:

It is recommended that this report be received and forwarded to Council for information.

Background:

Section No. 284(1) of The Municipal Act (S.O. 2001), provides that the Treasurer of a municipality shall submit to the Council of the municipality, in each year, a statement of the remuneration and expenses paid in the previous year to each Member of Council in respect of his or her services as a Member of Council or as an officer of the municipality and also to each Member of Council or other person appointed by Council to a Local Board or other Special Purpose Body.

Comments:

This report is on the remuneration earned and expenses paid to Members of Council and Council Appointees to Local Boards and other Special Purpose Bodies for the year 2005, and is outlined in two sections. Section A has the remuneration and expenses of Members of Council and Section B the remuneration and expenses of Council Appointees to Local Boards and other Special Purpose Bodies.

(a) Members of Council

The Table 1 below summarizes the remuneration earned and expenses paid to Members of Council for the year ended December 31, 2005. It includes remuneration and expenses paid by Local Boards, Special Purpose Bodies and City Divisions. Note

- 1. The remuneration reported is the amount earned in the year 2005 and includes, for certain Councillors, remuneration received from the Local Boards and other Special Purpose Bodies as disclosed on Section (b) of this report.
- (b) Council Appointees to Local Boards and other Special Purpose Bodies

The remuneration and expenses summarized in Appendix H have been paid by the respective Local Board or other Special Purpose Body. The amounts pertaining to members of Council are included in the summary on Table 1 above.

All City Agencies, Boards, Commissions and Corporations (ABCC's), with the exception of Enwave Energy Corporation (Enwave), have confirmed payments that are in accordance with the Remuneration and Expense Reimbursement Policy approved by Council in September 2003. In the case of Enwave, City Council in December 2005 set new rates of remuneration for the Chair and citizen members effective with the new term of the Board. The actual remuneration paid in 2005 exceeded the rates of remuneration previously set by Council, and Enwave has been advised of the change in rates. Enwave has confirmed that it will be adjusting the remuneration to match the new rates approved by Council effective February 2006, when the new Board took office.

In the case of the Toronto and Region Conservation Authority (the Authority), under the terms of section 37 of the Conservation Authorities Act, the Authority can pay salaries and expenses of its members upon approval of the Ontario Municipal Board. The Authority has obtained this approval and confirmed as having paid the remuneration and expenses reported in Appendix H to members appointed by Council for the year 2005. It should be noted that Council, at its meeting of April 16 to 18, 2002, in adopting Clause 26 of Report No. 4 of the Administration Committee adopted a recommendation that: "The individual Members of Council who are members of the Conservation Authority be requested to decline the remuneration being offered by the Conservation Authority."

Conclusions:

This report is submitted for information purposes as required under Section No. 284(1) of the Municipal Act (S.O. 2001) and provides a statement of Remuneration and Expenses of Members of Council and of Council Appointees to Local Boards and other Special Purpose Bodies for the year ended December 31, 2005.

Subject: Adjustments to the 2005 Council Remuneration Report

Purpose:

The purpose of this report is to respond to the following recommendation made at the March 6, 2006, Administration Committee meeting:

"that the Treasurer report directly to Council on action the Treasurer could take with respect to noting Councillor Shiner's concerns about photocopying expenses."

Financial Implications and Impact Statement:

There are no financial implications as a result of this report.

Recommendation:

It is recommended that this report be received for information.

Background:

At the March 6, 2006 Administration Committee meeting, Councillor Shiner raised a concern that the photocopying charges attributed to his office expense account were overstated in the 2005 report on Council remuneration and expenses. He explained that his office could not have possibly used that many copies and that someone else must have used his office's copier password. He asked that his account be adjusted accordingly.

Comments:

Staff prepared the remuneration and expense report based on the information provided within the City's financial system. Councillors receive regular reports on the expenses of their office and the expectation is that should a Councillor be concerned about the charges against their accounts that they would raise them to the Director of Council Services to investigate and correct. Accounting Services staff prepare the remuneration report in February after the year end entries have been entered into the financial system and the books are closed. No more entries are allowed except those that are required for accounting for the City's ABC results and for any entries recommended by the City's external auditors.

The correcting entry requested by Councillor Shiner is past the closing date and staff are not recommending that the City's books be re-opened. However, should Council wish to accommodate Councillor Shiner's request, they could pass a motion asking staff to amend the Table 1 and Appendix B to the report for the permanent record including a footnote to Councillor Shiner's account for photocopying charges, identifying the amount disputed and the actual amount once the disputed amount is removed. The footnote would also explain the action that Council took. This would provide an adjustment to Councillor Shiner's photocopying expenses, show the adjusted amount, and provide an audit trail on the changes. The amended table and appendix is attached for Council's consideration.

Conclusions:

Staff are not recommending that the City's accounting records be re-opened to accommodate Councillor Shiner's request for a correction. Council could pass a motion to request staff to amend the remuneration and expense report. However, Council should consider this request as a one-time exception which does not set a precedent for dealing with future disagreements over the amounts reported in the remuneration and expense report. Concerns over office expense charges should be raised to the Director of Council Services as the regular financial reports are produced prior to year end.

Subject: Councillors' Use of Constituency Offices and Touch-down Space at Civic Centres

<u>Purpose</u>:

This report provides an overview of Councillors' use of constituency offices and touch-down space at civic centres, and outlines current policies concerning constituency offices. The report also responds to Councillor Mammoliti's enquiry concerning some Councillors' use of touch-down space at the Etobicoke Civic Centre and whether rent has been paid on usage of the space.

Financial Implications and Impact Statement:

There are no financial implications from the receipt of this report.

The Deputy City Manager and Chief Financial Officer has reviewed this report and concurs with the financial impact.

Recommendations:

It is recommended that this report be received for information.

Background:

At its May 23, 24 and 25 meeting, Toronto City Council postponed consideration of Clause 6a of Administration Report No. 2, titled "Remuneration and Expenses of Members of Council and of the Council Appointees to Local Boards and Other Special Purpose Bodies for the year ended December 31, 2005." Councillor Mammoliti requested the City Clerk to report on the usage of touch-down space by Councillors, in particular at the Etobicoke Civic Centre, and whether rent has been paid for the space. The Councillor also requested that the City Clerk provide a summary of the policies governing the use of Councillors' constituency office and touchdown space.

Since the formation of the amalgamated City of Toronto in 1998, four reports made reference to Councillor's constituency offices, including how expenses relating to constituency offices are to be charged.

At its meeting of June 3, 4 and 5, 1998, City Council adopted Clause 13 of Report No. 7 of the Corporate Services Committee, titled "Office Administration and Expenses of Members of Council." Point (7) in Appendix A of the report outlined the policies relating to Constituency Office Expenses.

At its meeting of February 29, March 1 and 2, 2000, City Council considered Clause 2 of Report No. 4 of the Administration Committee, titled "Expenses of Members of Council." Recommendation 3(c) of the report directed the Commissioner of Corporate Services "to ensure that the policy for constituency office space for Members of Council is reported to Council by January 2001, such policy to incorporate a provision for charge back based on square footage use."

At its meeting held on January 30 & 31, February 1, 2001, Toronto City Council considered Clause 1 of Report No. 1 of Administration Committee, a report from the Commissioner of Corporate Services, titled "Options for Constituency Offices and Reallocation of Vacant Second Floor Office Space at City Hall" and adopted the following recommendations concerning constituency offices:

- (1) all Members of Council be provided with approximately equivalent office space and be granted a choice of a constituency office within their respective wards or within a Civic Centre or equivalent office space at City Hall;
- (2) for each site over and above the City Hall office, the cost be borne by the Councillor's Global office budget;
- (3) the rent/lease costs for constituency offices located in former Civic Centres or other City of Toronto buildings, including Toronto City Hall, be set at the same rate, and that the rate be set at \$400.00 per month for a maximum total of 500 square feet, the amount to be charged back to the Councillor's Global office budget;
- (4) Option No. 2 embodied in the report dated January 22, 2001, from the Commissioner of Corporate Services, be adopted, so that such Option shall now read as follows:
 - "Option 2: the office leases in question could be taken in the City's name, in which case City staff (Facilities and Real Estate) would negotiate the terms of the lease in consultation with the relevant Councillor, and the City Solicitor would negotiate the form of leasing documentation, subject to the Commissioner of Corporate Services, in consultation with the City Solicitor, submitting a report to the Administration Committee on a set of policies to govern such leases."

Council also adopted Recommendation (6), which states that Councillors be given access to a telephone and computers in the Civic Centres, when necessary, and be able to book appropriate space in the Civic Centres to meet with staff and constituents at no additional cost. This is the only reference to any policy concerning "touch-down space".

At its meeting of July 24, 25 and 26, 2001, City Council adopted Clause 2 of Report No. 11 of the Administration Committee, a further report from the Commissioner of Corporate Services, titled "Policies/Guidelines to Govern Constituency Office Leases and Policies Respecting Goods, Services and Space Below Market Value." The report set out policies and guidelines for leases of constituency offices in the name of the City as lessee, as contained in Appendix B of the report.

Comments:

Current Use of Space by City Councillors

In order to capture the types of space used by Councillors, City Clerk's Office staff consulted with Facilities and Real Estate Division and Parks, Forestry and Recreation Division in the preparation of this report.

Staff are aware of five types of space being used by Councillors:

- Councillor City Hall Offices
- Councillor Constituency Offices, either at City Hall, a Civic Centre, a City facility or private property
- Touch-down space at Civic Centres
- Councillor use of home as office
- Councillor use of community space for meetings with constituents

All Councillors are provided with office space on the second floor of Toronto City Hall. These spaces are provided free.

Attachment 1 provides an overview of Councillor constituency offices. As the summary shows, in addition to their City Hall offices, 19 Councillors have constituency offices at City Hall or Civic Centres, eight Councillors rent space in private facilities for their constituency offices, and one Councillor leases Parks, Forestry and Recreation space for his constituency office.

In addition to constituency offices, there are touch-down spaces established at 4 civic centres – 1 work station space at Scarborough Civic Centre, 3 work station spaces at North York Civic Centre, 1 office space in York Civic Centre, and 6 office spaces at Etobicoke Civic Centre. All spaces are equipped with a telephone and a computer, but the sizes, types and furnishings of the spaces vary.

Some Councillors and/or their staff also use their homes as offices. The Council Operations Manual states that the City would pay for one each of high-speed internet, telephone and fax line for these home constituency offices, similar to the payment for constituency offices at private property. Councillors who use their homes as offices and wish the City to pay for these expenses must advise the Council and Support Services Unit in writing. The usage of homes as offices is not captured in the summary.

Some Councillors also use community space for meetings with constituents. Such space can include libraries, arenas, tennis clubs, and other City facilities. Rent may or may not be paid for the use of such community space.

Policies Guiding Constituency Office and Touch-Down Space

Two Council reports in 2001 set out the policies and guidelines concerning constituency offices. Attachment 2 outlines these policies. Highlights of the policies include:

- An official lease is drawn up for the constituency office, either at a City facility or a private property;
- For a leased space in private property, rent is charged for the leased space at fair market value and terms and conditions reflect commercial leases and in accordance with the terms and conditions as contained in Appendix B in the July 2001 Administration Committee report;
- Rent/lease costs for constituency offices located in former Civic Centres or other City of Toronto buildings, including Toronto City Hall, be set at \$400 per month for a maximum of 500 square feet;
- Rent/lease costs are charged back to the Councillor's office budget.

In addition, under current practice for City owned buildings, the lease includes one computer, phone line and set, insurance, heat, hydro, cable, high speed internet, basic office furniture (desk, chair, file cabinet). For private leased buildings, the City pays for phone and fax lines and high speed internet. The City also pays for insurance, heat and hydro if the lease does not include these costs.

Touch-down spaces are provided for Councillors at the civic centres, enabling Councillors or their staff to make short phone calls, check e-mails or hold short meetings. While the intent is that touch-down spaces are for the short-term use and are not assigned to any one Councillor, there are no Council-approved policies that govern their usage -- whether Councillors can regularly and continuously use one space; whether they can put identification signage or other personal artwork in the space; whether they can leave personal files and other belongings in the space; and whether they can bring in personal furniture. Usage of touch-down space is not monitored, with no sign-in or logging system.

There are no guidelines or policies governing Councillors who use their homes as offices or Councillors' use of community space for meetings with constituents.

On instances where Councillors accept office space or other goods and services from business and/or clients within the Councillor's community, the July 2001 Administration Committee report stated that "acceptance of office space at a rate that is below market value contravenes Council's Code of Conduct and expense policies for Members of Council. Acceptance of this space could also have the effect of requiring a member to declare a conflict of interest under the Municipal Conflict of Interest Act, and in some circumstances, could even result in a charge of breach of trust under the Criminal Code."

However, the report did not address the issue of what constitutes "office space" or whether a community group is included in the statement regarding space from business or clients [constituents].

Councillor Mammoliti's enquiry re the Etobicoke Civic Centre Touch-down Space

The touch-down space at Etobicoke Civic Centre is different from the touch-down spaces at North York or Scarborough Civic Centre in that they are private offices with doors and not just work stations. However, the doors are operated by one generic key. The security officer on duty at the entrance to the Councillors' area normally opens the doors to the touch-down offices for

the Councillors or their staff. Since there have been instances when the security officer may not be readily available, especially during weekends and after hours, copies of the generic key have been made available for all members of the Etobicoke and York Community Council and the members have been advised of the availability of such a generic key.

Councillor Mammoliti alleged that two Councillors regularly use two touch-down spaces at the Etobicoke Civic Centre and have virtually used the space as constituency offices with a name plate on the door, personal artwork on the walls, and personal files, belongings and furniture inside the office. The Councillor requested a report on whether rent has been paid by the two Councillors for the space.

Facilities and Real Estate staff have confirmed that they have no record of current leases for constituency offices at Etobicoke Civic Centre. Council and Support Services have also not processed any rent being charged against any Councillor's office budget for use of space at the Etobicoke Civic Centre.

Subsequent to receipt of the enquiries and photographs from Councillor Mammoliti, staff attended the space and spoke with the security officer stationed at the entrance to the area. While there is some evidence that two of the offices are in use, with the sign of one Councillor on the wall of one office, and personal belongings of another Councillor in another office, it is almost impossible for staff to determine the usage of the space and when a regularly used touchdown space becomes a constituency office.

If there is no lease agreement, but the Councillor uses the space regularly, does that become a constituency office? And what is the definition of using a space regularly? If a Councillor frequently uses touch-down space at a civic centre, but uses a different office each time, does that constitute having a constituency office? Councillors who use the space can counter argue that any other Councillor can come in, push aside their personal files, and use the touch-down space, as they do not possess a personal key to lock up the space. In fact, the usage of the touch-down space by the Councillors at Etobicoke Civic Centre is similar to the use of community space by some Councillors. The absence of a Council-approved policy makes it difficult for staff to make a determination.

The unique nature of the touch-down space at Etobicoke Civic Centre, being distinct offices, may have contributed to the perception of exclusivity of usage. If Council so wishes, staff can investigate whether changes to the space can be made so that the touch-down space at Etobicoke Civic Centre more closely resembles the touch-down work stations at North York and Scarborough Civic Centre.

Additional Issues

Very late in the development of this report, two additional issues have surfaced. First, there are some Councillors who refused to sign leases with the City for the constituency offices in the Civic Centres. In addition, some offices, due to historical and physical reasons, are larger than the maximum area of 500 square feet, as indicated in the 2001 Administration Committee Report. Because of the time frame, staff have not been able to look further into these issues.

Conclusions:

Councillors can choose to rent space at civic centres, private properties or other City facilities for their constituency offices. In addition, Councillors can use touch-down spaces at civic centres for their phone calls, e-mails or short meetings. Previous reports adopted by Council have set out policies concerning constituency offices but did not set out policies or guidelines on usage of Councillors' touch-down spaces at civic centres.

Attachment 2 Council-Approved Policies Concerning Constituency Offices

Clause 1 of Report No. 1 of Administration Committee, report from the Commissioner of Corporate Services, titled "Options for Constituency Offices and Reallocation of Vacant Second Floor Office Space at City Hall", adopted by Council on January 30 & 31, February 1, 2001, stipulates:

- all Members of Council be provided with approximately equivalent office space and be granted a choice of a constituency office within their respective wards or within a Civic Centre or equivalent office space at City Hall;
- for each site over and above the City Hall office, the cost be borne by the Councillor's Global office budget;
- the rent/lease costs for constituency offices located in former Civic Centres or other City of Toronto buildings, including Toronto City Hall, be set at the same rate, and that the rate be set at \$400.00 per month for a maximum total of 500 square feet, the amount to be charged back to the Councillor's Global office budget;
- the office leases in question could be taken in the City's name, in which case City staff (Facilities and Real Estate) would negotiate the terms of the lease in consultation with the relevant Councillor, and the City Solicitor would negotiate the form of leasing documentation, subject to the Commissioner of Corporate Services, in consultation with the City Solicitor, submitting a report to the Administration Committee on a set of policies to govern such leases.

Clause No. 2, Report No. 11 of Administration Committee, approved by Council in July 24, 25 and 26, 2001, states:

"Should any Member of Council wish to lease a constituency office on the basis that the lease will be in the City's name as lessee, the lease terms and conditions should reflect the terms and conditions set out in Appendix B, which provide for a fair and reasonable market rent and the terms and conditions of a commercial lease for office space. Having the lease in the City's name and negotiated by City staff should remove any concerns regarding compliance with the Code of Conduct or a potential conflict of interest. Conversely, should any Member of Council wish to proceed with a leasing arrangement on his or own as lessee, although those members will be proceeding independently, the Councillor may wish to consider inclusion of the terms and conditions in items one to eight of Appendix B.

Appendix B:

- the Leased Premises must be within the ward of the elected Councillor;
- the term of the lease shall not exceed the term of Council;
- the option to renew, if any, must be conditional on the Councillor being re-elected;
- the net rent is to be at market rent, and the lease terms and conditions are to reflect commercial leases;
- all costs associated with the lease, including leasehold improvements, all costs of the lease, parking etc. must be covered within the approved budget of each Councillor;
- the use of the Leased Premises shall be strictly for constituency office purposes only;

- there shall be no subletting of the space;
- the lease shall terminate automatically should the Councillor's term end for any reason;
- all leasing arrangements must be negotiated by Facilities and Real Estate staff, with the leasing documentation to be in a form satisfactory to the City Solicitor.
