Bill 876

BY-LAW -2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bloor Street West, Dundas Street West and Kipling Avenue.

Whereas City Council on February 2, 3 and 5, 2021 adopted Item IE19.9, wherein the report (December 18, 2020) from the General Manager, Transportation Services, recommended prohibiting turns on red signals on Bloor Street West and Dundas Street West to be inserted into Schedule XIII (Prohibited Turns), City of Toronto Municipal Code Chapter 950, Traffic and Parking;

Whereas City Council on February 5, 2021 enacted By-law 38-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bloor Street West, Dundas Street West, Kipling Avenue in Wards 2 and 3.", which incorrectly included the times and/or Days as "Anytime" instead of "When traffic control signal shows red" in the 4th column entry;

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(From Column 1 Intersection or Portion of Highway)	(From Column 2 Direction)	(From Column 3 Turns Prohibited)	(From Column 4 Times and/or Days)
Bloor Street West and Dundas Street West	All Directions	Right	Anytime
Bloor Street West and Kipling Avenue	All Directions	Right	Anytime

B. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Bloor Street West and Dundas Street West	All Directions	Right	When traffic control signal shows red
Bloor Street West and Kipling Avenue	All Directions	Right	When traffic control signal shows red
Dundas Street West and Dundas Street West	Northbound	Right	When traffic control signal shows red
Dundas Street West and Kipling Avenue	All Directions	Right	When traffic control signal shows red
