Bill 252

BY-LAW -2024

To amend City of Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties, to delete Schedule G (RUAC Properties (rebates)).

To amend City of Toronto Municipal Code Chapter 844, Waste Collection, Residential Properties, to amend Schedule D (Residential Curbside Collection, Multi-Residential Curbside Property and Multi-Residential Front-end Collection (rebates)).

Whereas Council, through the 2023 Property Taxes, User Fees and Related Matters report approved the continuation of the Solid Waste Rebates for Low Income Seniors, Disabled and Multi-Residential customers;

Whereas certain classes of rebates have been reduced to \$0 and it is now necessary to delete these tables in their entirety and update Chapter 841, Waste Collection, Commercial Properties and Municipal Code Chapter 844, Waste Collection, Residential Properties, to reflect the removal and continuation of various rebates as approved by Council;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 841, Waste Collection, Commercial Properties, is amended by deleting in its entirety Schedule G (RUAC Properties (rebates)).
2. Municipal Code Chapter 844, Waste Collection, Residential Properties, is amended by deleting in its entirety Schedule D (Residential Curbside Collection, Multi-Residential Curbside Property and Multi-Residential Front-end Collection (rebates)) and replacing it with the new Schedule D (Multi-Residential Curbside Property and Multi-Residential Front-end Collection (rebates)) attached as Appendix A to this By-law.
3. Appendix A to this By-law shall come into force upon enactment.
4. The rates, fees, and charges enacted by this By-law shall continue in full force and effect until such time as they are amended or repealed by the Council of the City of Toronto.
