**Bill 198**

**BY-LAW -2025**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Blackthorn Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| Blackthorn Avenue             | West                       | Kenora Crescent and a point 50 metres north of Aileen Avenue | From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive |
| Blackthorn Avenue             | West                       | Rogers Road and a point 38.8 metres north of Rowntree Avenue | From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive |
