Bill 230

BY-LAW -2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Yonge Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule IX (Delivery Vehicle Parking Zones) in § 950-1308, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Location) | (From Column 4 Times and/or Days) | (From Column 5 Maximum Period Permitted) |
|-------------------------------|----------------------------|--|---|---|
| Yonge Street | East | A point 85.7 metres north of St. Clair Avenue East and a point 20 metres further north | Anytime | 20 mins. |

B. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------------|----------------------------|---|---|
| Yonge Street | East | A point 85.7 metres north of St. Clair Avenue East and a point 30.5 metres north of Roxborough Street West (north intersection) | Anytime |
| Yonge Street | East | Heath Street and a point 105.7 metres north of St. Clair Avenue East | Anytime |

- C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------------|--------------------------|---|---|
| Yonge Street | East | Heath Street East and a point 30.5 metres north of Roxborough Street East | Anytime |

- D. By deleting from Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

| (From Column 1 Intersection or Portion of Highway) | (From Column 2 Direction) | (From Column 3 Turns Prohibited) | (From Column 4 Times and/or Days) |
|---|---------------------------------|---|---|
| Yonge Street and a point 111 metres north of St. Clair Avenue East (the parking lot access at No. 1501 Yonge Street) | Westbound | Left | Anytime |
| Yonge Street and a point 111 metres north of St. Clair Avenue East (the parking lot access at No. 1501 Yonge Street) | Southbound | Left | 6:00 a.m. to 7:00 p.m. |

- E. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

| (In Column 1 Intersection or Portion of Highway) | (In Column 2 Direction) | (In Column 3 Turns Prohibited) | (In Column 4 Times and/or Days) |
|---|-------------------------------|---|---------------------------------------|
| Yonge Street and Delisle Avenue/Private Driveway | Southbound | Left | Anytime (bicycles excepted) |

F. By deleting from Schedule XXIV (Compulsory Turns) in § 950-1323, the following in alphabetical order by street name:

| (From Column 1 Highway Being Entered) | (From Column 2 Highway from which Vehicle Enters) | (From Column 3 Highway Not To Be Entered) |
|---|--|---|
| Yonge Street | Parking lot access/driveway opposite DeLisle Avenue | DeLisle Avenue |

G. By inserting in Schedule XXIV (Compulsory Turns) in § 950-1323, the following in alphabetical order by street name:

| (In Column 1 Highway Being Entered) | (In Column 2 Highway from which Vehicle Enters) | (In Column 3 Highway Not To Be Entered) |
|---|--|---|
| Yonge Street | Delisle Avenue | Delisle Avenue (bicycles excepted) |
