BY-LAW- 2025

To amend City of Toronto Municipal Code Chapter 67, Fair Wage.

The Council of the City of Toronto enacts:

1. City of Toronto Municipal Code Chapter 67, Fair Wage is amended as follows:

(A) by adding the following as a new subsection 6G:

G. Residential work.

(B) by adding the following as a new section B2.1:

§ 67-B2.1 Current labour trades contractual obligations in the residential sector.

The City of Toronto is bound by the current collective agreements with respect to the residential sector between the City of Toronto and:

A. Carpenters' Regional Council, United Brotherhood of Carpenters and Joiners of America.

(C) by adding Attachment 1 of this by-law to Schedule C, Fair Wage Schedule 2022 – 2025.

2. This by-law shall come into force on May 1, 2025.

(Not applicable to setting door or windowsills, garage floor bulkheads, sidewalk or deck forms).</p> <p>*NOTE 2: The category of Combination Skilled Worker applies to an Employee who is skilled and actually performs pipelaying, cement finishing and carpenter, formsetter work.</p>						

***FRINGE BENEFITS:** "Fringe Benefits" shall include such benefits as company pension plans, apprenticeship training, extended health care benefits, dental and prescription drugs, etc. It does NOT include payroll burden deductions such as C.P.P., E.H.T., W.S.I.B., E.I.C., etc.

*** VACATION AND HOLIDAY PAY:** For contractors that do not offer "fringe benefits" to their workers, the fringe benefits hourly rate shall be added to the hourly or weekly rate as shown above.
