BY-LAW -2026

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Carlaw Avenue, De Grassi Street and Queen Street East.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Carlaw Avenue	East	Gerrard Street East and a point 20 metres north of Badgerow Avenue	4:00 p.m. to 6:00 p.m., Monday to Friday, except public holidays
De Grassi Street	West	Queen Street East and Cummings Street	Anytime
Queen Street East	North	Boulton Avenue and McGee Street	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Carlaw Avenue	East	A point approximately 15 metres south of Gerrard Street East and a point 20 metres north of Badgerow Avenue	4:00 p.m. to 6:00 p.m., Monday to Friday, except public holidays
De Grassi Street	West	A point approximately 85 metres north of Queen Street East and Cummings Street	Anytime

Gerrard Street East	North	Parliament Street and Carlaw Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri, except public holidays
Gerrard Street East	South	Carlaw Avenue and a point 100 metres east	Anytime
Gerrard Street East	South	A point 100 metres east of Carlaw Avenue and Victoria Park Avenue	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Gerrard Street East	South	A point 100 metres east of Carlaw Avenue and Pape Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri.; 8:00 a.m. to 6:00 p.m., Sat.	1 hour

2. This By-law shall be effective commencing August 1, 2026.
