**Bill 1193**

**BY-LAW -2026**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dreamers Way and Gerrard Street East.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:
