BY-LAW -2026

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Dufferin Street, Jameson Avenue and Springhurst Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Dufferin Street	West	Between a point 38 metres north of Thorburn Avenue and a point 29 metres south of King Street West	23	Anytime from Fri. Aug. 21, 2026, to Mon. Sept. 7, 2026, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dufferin Street	East	A point 15 metres north of Springhurst Avenue and King Street Wes	Anytime from Fri. Aug. 21, 2026, to Mon. Sept. 7, 2026, inclusive

C. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Springhurst Avenue	South	Dunn Avenue and Dufferin Street	Anytime from Fri. Aug. 21, 2026, to Mon. Sept. 7, 2026, inclusive

D. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Springhurst Avenue	Jameson Avenue and Dufferin Street	Anytime from Fri. Aug. 21, 2026, to Mon. Sept. 7, 2026, inclusive	Westbound

E. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Springhurst Avenue and Jameson Avenue	Westbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., from Fri. Aug. 21, 2026, to Mon. Sept. 7, 2026, inclusive

F. By inserting a new Subsection (14) in § 950-1202A as follows:

"(14) During the time frame indicated in the entry in Subsection 1A to 1E, inclusive, of By-law ~~XXXX~~-2026, the provisions of Subsections 1A to 1E of By-law ~~XXXX~~-2026 shall apply notwithstanding anything to the contrary in any other by-law or chapter of the Municipal Code. For further clarity, where any regulation contained in Subsection 1A to 1E, inclusive, of By-law ~~XXXX~~-2026 conflicts with any other regulation in any Schedule of the Municipal Code Chapter 950, Traffic and Parking, the regulation as found in By-law ~~XXXX~~-2026 shall prevail during the time frame outlined in the regulation as found in By-law ~~XXXX~~- 2026."
