BY-LAW -2026

To amend Toronto Municipal Code Chapter 441, Fees and Charges.

Whereas section 259 of the City of Toronto Act, 2006 provides that the City may pass by-laws imposing fees and charges on persons for services or activities provided or done by or on behalf of it; and;

Whereas Toronto Municipal Code, Chapter 349, Animals requires owners of certain animals to pay licence fees in the amounts specified in Toronto Municipal Code Chapter 441, Fees and Charges; and

Whereas City Council determined it was necessary to clarify the use of the fees set out in Toronto Municipal Code Chapter 441, Fees and Charges related to pet licensing and to apply annual inflationary adjustments to align with operational practice for other animal-related fees; and

Whereas notice of the intention to enact this by-law has been provided in accordance with the City of Toronto Act, 2006;

The Council of the City of Toronto enacts:
