BY-LAW -2026

To permanently close portions of Dundas Street West, Kipling Avenue and Bloor Street West.

WHEREAS it is recommended that portions of the public highways known as Dundas Street West, Kipling Avenue and Bloor Street West be permanently closed as public highways;
and

WHEREAS notice of the proposed by-law to permanently close portions of the said public highways was posted on the notices page of the City's website in accordance with the requirements of City of Toronto Municipal Code Chapter 162, Notice, Public, and the Etobicoke York Community Council heard any person who wished to speak to the matter at its meeting held on July 7, 2026;

The Council of the City of Toronto enacts:
