CITY OF TORONTO

BY-LAW No. 195-1999

To amend By-law No. 912-1998, being “A By-law To authorize the erection, operation, use and maintenance of parking machines on the highways under the jurisdiction of the City of Toronto, including the setting of fees or fee scales”, to establish and set the rates for parking machines to be located on Danforth Avenue, north side, from Jackman Avenue to Langford Avenue, and Danforth Avenue, south side, from Bowden Street to Langford Avenue.

WHEREAS, by the *City of Toronto Act, 1997 (No. 2)* and the *Municipal Act*, the Council of the City may delegate to the Toronto Parking Authority the construction, maintenance, operation and management of parking operations and facilities; and

WHEREAS City Council has directed that pay and display parking machines be installed on Danforth Avenue, north side, from Jackman Avenue to Langford Avenue, and Danforth Avenue, south side, from Bowden Street to Langford Avenue;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 912-1998, being “A By-law To authorize the erection, operation, use and maintenance of parking machines on the highways under the jurisdiction of the City of Toronto, including the setting of fees or fee scales”, is amended by adding the following to Schedule “A” in alphabetical order:
