BY-LAW No. 95-2002

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on
former Metropolitan Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1.** Schedule IV (Stands for Taxicabs) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
York Mills Road (M.T. 24)	North	Between a point 219 metres east of Yonge Street and a point 25 metres further east thereof	4	Anytime

- 2.** Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Yonge Street (M.T. 29)	East	A point 105.5 metres north of Blythwood Road and a point 29 metres further north thereof	Anytime

- 3.** Schedule XIII (One-Way Traffic Lanes) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Leslie Street and York Mills Road (M.T. 61)	York Mills Road and a point 70 metres north thereof	Westerly Southbound	Anytime	Southbound right-turning (buses excepted)

4. Schedule XV (Prohibited Turns) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

York Mills Road and York Ridge Road (M.T. 24)	Eastbound	Left	Anytime
