BY-LAW No. 37-2003

To amend By-law No. 31878, as amended, of the former City of North York.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That Section 1 of By-law No. 31878 of the former City of North York, is amended by deleting the following:

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
CULFORD RD.	A POINT 30 M NORTH OF THE NORTHERLY LIMIT OF MAPLE LEAF DR.	A POINT 150 M NORTH OF THE NORTHERLY LIMIT OF RUSTIC RD.
DEL RIA DR.	THE SOUTHERLY LIMIT OF GRACEFIELD AVE.	A POINT 275 M EAST OF THE EASTERLY LIMIT OF CULFORD RD.
GARY DR.	THE WESTERLY LIMIT OF FARNSWORTH DR.	THE EASTERLY LIMIT OF RANWOOD DR.
GARY DR.	THE WESTERLY LIMIT OF WENDELL AVE.	THE EASTERLY LIMIT OF YELLAND ST.

2. That Section 1 of By-law No. 31878 of the former City of North York, is amended by adding the following:

CULFORD RD.	THE NORTHERLY LIMIT OF LAWRENCE AVE. W.	THE SOUTHERLY LIMIT OF FALSTAFF AVE.
DEL RIA DR.	THE SOUTHERLY LIMIT OF GRACEFIELD AVE.	THE EASTERLY LIMIT OF CULFORD RD.
FALSTAFF AVE.	THE EASTERLY LIMIT OF FLEET WOOD AVE.	THE WESTERLY LIMIT OF KEELE ST.
GARY DR.	THE WESTERLY LIMIT OF YELLAND ST.	THE EASTERLY LIMIT OF GARY DR.

<u>HIGHWAY</u>	<u>FROM</u>	<u>TO</u>
PELMO CRES.	THE SOUTHERLY LIMIT OF GARY DR.	THE WESTERLY LIMIT OF UPHILL AVE.
VALENCIA CRES.	THE EASTERLY LIMIT OF CULFORD RD.	THE SOUTHERLY LIMIT OF DEL RIA DR.
WYNDALE DR.	THE EASTERLY LIMIT OF CULFORD RD.	THE WESTERLY LIMIT OF KEELE ST.

3. That Section 1 of By-law No. 31878, as amended, be and the same is hereby confirmed.
