**CITY OF TORONTO**

**BY-LAW No. 45-2003**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Church-Wellesley Business Improvement Area and to establish a Board of Management for the Church-Wellesley Business Improvement Area.**

WHEREAS Council, at its meeting held on November 19, 20 and 21, 2002 by its adoption of Clause No. 13 of Economic Development and Parks Committee Report No. 10, authorized the designation of an area on both sides of Church Street from Gloucester Street to Wood Street as a business improvement area under section 220 of the *Municipal Act*; and

WHEREAS by the adoption of Clause No. 8 of Economic Development and Parks Committee Report No. 2 on February 4, 5 and 6, 2003, City of Toronto Council established a board of management for the Church-Wellesley Business Improvement Area and appointed members to the Church-Wellesley Business Improvement Area Board of Management for a term expiring on November 30, 2003, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Church-Wellesley Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Church-Wellesley Board of Management as set out in Schedule A attached;
  - B. Schedule A, Maps is amended by adding the attached maps of the Church-Wellesley Business Improvement Area; and
  - C. The table in § 19-2 is amended by inserting in the first column "954-2002" and by inserting in the third column "Church-Wellesley".

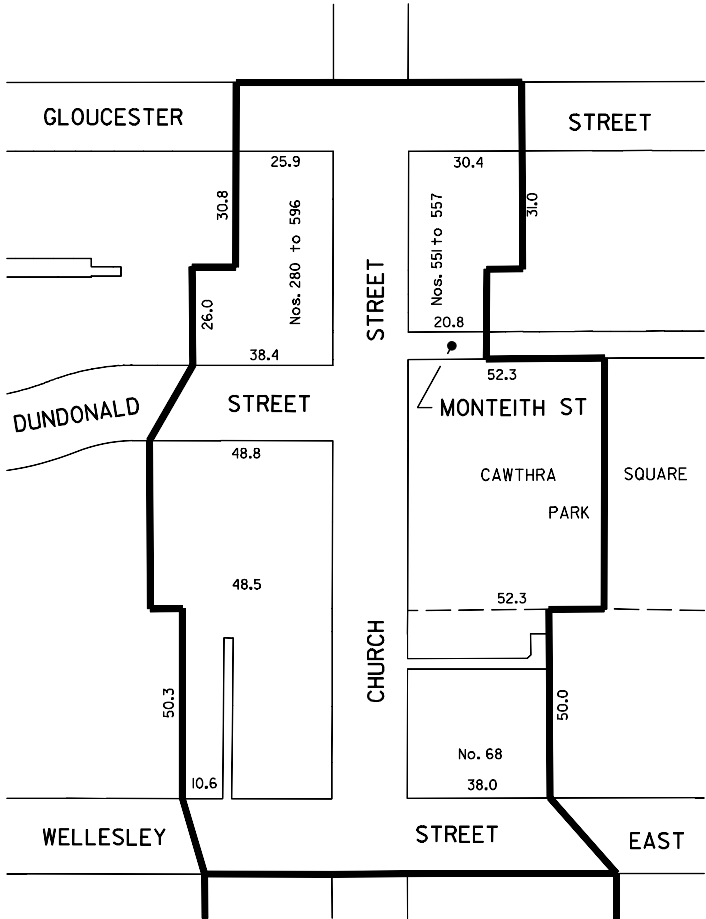

Map 1 of 3



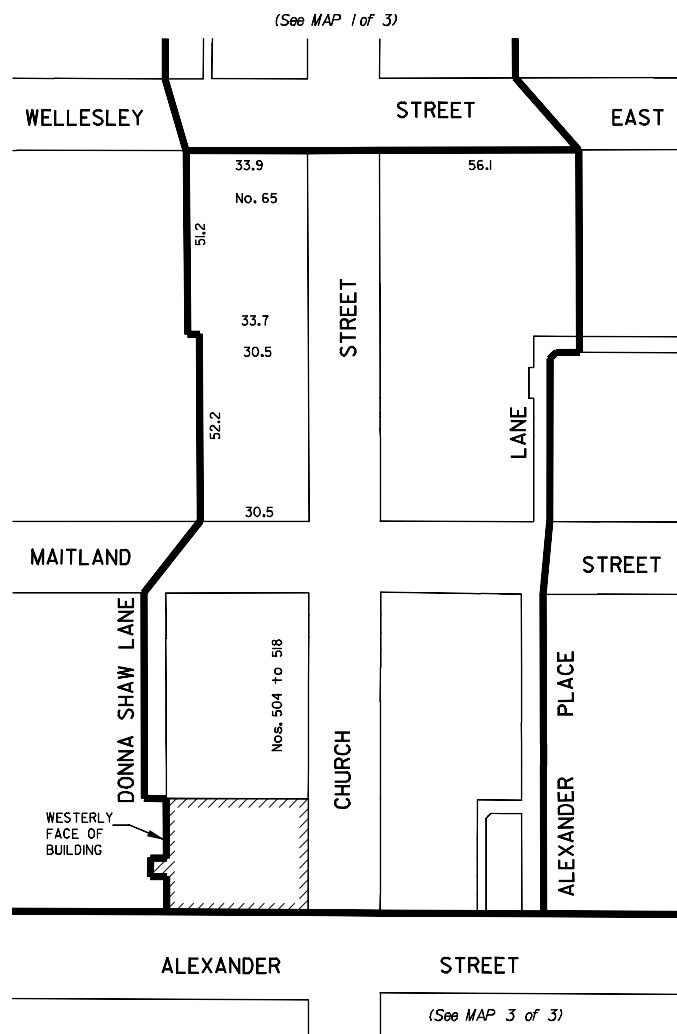
