BY-LAW No. 86-2003

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ellis Park Road, Franklin Avenue, Indian Road, Kenneth Avenue, Sheridan Avenue, Springmount Avenue, Lane first south of Davenport Road between Ossington Avenue and Somerset Avenue, Lane system south of Geoffrey Street and north of Westminster Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
