## **CITY OF TORONTO**

### **BY-LAW No. 162-2003**

#### **To amend By-law No. 196-84 of the former City of York, being a By-law “To regulate traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

#### NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Sidney Belsey Crescent	North and West and South	A point 40 metres east of Westpoint Lane (north junction) and Westpoint Lane (south junction)	Anytime

#### NO PARKING - SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 196-84, as amended be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Sidney Belsey Crescent	West and South	A point 174 metres west/south of Westpoint Lane (north junction) and Westpoint Lane (south junction)	Anytime

NO STOPPING - SCHEDULE IX

3. That Schedule IX of former City of York By-law No. 196-84, as amended be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Sidney Belsey Crescent	North	A point 40 metres east of Westpoint Lane (north junction) and a point 130 metres west thereof	Anytime

NO PARKING FOR RESTRICTED PERIODS - SCHEDULE X

4. That Schedule X of former City of York By-law No. 196-84, as amended be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period Permitted</u>
Sidney Belsey Crescent	West	A point 90 metres west of Westpoint Lane (north junction) and a point 84 metres south thereof	8:00 a.m. to 4:00 p.m., Monday to Friday	15 Min.
