## **CITY OF TORONTO**

### **BY-LAW No. 289-2003**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Carlaw Avenue, Dupont Street, Glebeholme Boulevard, lane system bounded by Bellwoods Avenue, Claremont Street and Shaftesbury Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule XX (Wide Vehicles) in § 400-73, the following in alphabetical order by street name:
