BY-LAW No. 318-2003

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Imperial Street, Pote Avenue, St. Clements Avenue and Shallmar Boulevard.**

The Council of the City of Toronto HEREBY ENACTS as follows:
