BY-LAW No. 325-2003

To amend further Metropolitan By-law No. 109-86, respecting maximum rates of speed on certain former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule I of Metropolitan By-law No. 109-86, as amended, being a By-law "To prescribe maximum rates of speed on certain Metropolitan Roads", is further amended by striking out the words and figures:

Don Valley Parkway (M.T. 201), northbound, between the 90 kilometres per hour Frederick G. Gardiner Expressway and a point approximately 480 metres south of Wynford Avenue

Don Valley Parkway (M.T. 201), northbound, between a point 90 kilometres per hour approximately 350 metres north of Wynford Drive and Highway No. 404

Don Valley Parkway (M.T. 201), southbound, between the 90 kilometres per hour Frederick G. Gardiner Expressway and a point approximately 300 metres south of Wynford Avenue

Don Valley Parkway (M.T. 201), southbound, between a point 90 kilometres per hour approximately 480 metres north of Wynford Drive and Highway No. 404

where they occur opposite each other in Columns 1 and 2 of the said Schedule and inserting in lieu thereof the following:

(In Column 1) (In Column 2)

Don Valley Parkway (M.T. 201), northbound, between the 90 kilometres per hour Frederick G. Gardiner Expressway and a point approximately 400 metres north of Pottery Road

Don Valley Parkway (M.T. 201), northbound, between a point 70 kilometres per hour approximately 400 metres north of Pottery Road and a point approximately 250 metres south of Millwood Road

Don Valley Parkway (M.T. 201), northbound, between a point 90 kilometres per hour approximately 250 metres south of Millwood Road and a point approximately 480 metres south of Wynford Drive

(In Column 1) (In Column 2)

Don Valley Parkway (M.T. 201), northbound, between a point 90 kilometres per hour approximately 350 metres north of Wynford Drive and a point approximately 480 metres south of Three Drive/Brookbanks Drive

Don Valley Parkway (M.T. 201), northbound, between a point 70 kilometres per hour Valleys approximately 480 metres south of Three Drive/Brookbanks Drive and a point approximately 260 metres south of Three Valleys Drive/Brookbanks Drive

Don Valley Parkway (M.T. 201), northbound, between a point 90 kilometres per hour approximately 260 metres south of Three Valleys Drive/Brookbanks Drive and Highway No. 404

Don Valley Parkway (M.T. 201), southbound, between the 90 kilometres per hour Frederick G. Gardiner Expressway and a point approximately 400 metres north of Pottery Road

Don Valley Parkway (M.T. 201), southbound, between a point 70 kilometres per hour 400 metres north of Pottery Road and a point approximately 150 metres south of Millwood Road

Don Valley Parkway (M.T. 201), southbound, between a point 90 kilometres per hour approximately 150 metres south of Millwood Road and a point approximately 300 metres south of Wynford Drive

Don Valley Parkway (M.T. 201), southbound, between a point 90 kilometres per hour approximately 480 metres north of Wynford Drive and a point approximately 500 metres south of Three Valleys Drive/Brookbanks Drive

Don Valley Parkway (M.T. 201), southbound, between a point 70 kilometres per hour approximately 500 metres south Three of Valleys Drive/Brookbanks Drive and a point approximately 230 metres south of Three Valleys Drive/Brookbanks Drive

Don Valley Parkway (M.T. 201), southbound, between a point 90 kilometres per hour approximately south of Three Valleys 230 metres Drive/Brookbanks Drive and Highway No. 404

2. This by-law shall be effective commencing on or about May 2, 2003.
