**CITY OF TORONTO**

**BY-LAW No. 342-2003**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Earls court Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Earls court Avenue	West	Ascot Avenue and Morrison Street	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Earls court Avenue	West	Morrison Street and the north City limit	Anytime
