## **CITY OF TORONTO**

### **BY-LAW No. 348-2003**

#### **To amend By-law No. 196-84 of the former City of York, being a by-law “To regulate traffic on City of York Roads.”**

The Council of the City of Toronto HEREBY ENACTS as follows:

#### NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Earlscourt Avenue	East	The southerly City of York limits and Rogers Road	From 7 p.m. on the 1st day of each month to 7 p.m. on the 16th day of each month, April 1st to December 1st
Earlscourt Avenue	West	The southerly City of York limits and Rogers Road	From 7 p.m. on the 16th day of each month to 7 p.m. on the 1st day of each month, April 1st to December 1st
Earlscourt Avenue	West	The southerly City of York limits and Rogers Road	Anytime, from 7 p.m. on the 1st day of December to 7 p.m. on the 1st day of April

#### NO PARKING - SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Earlscourt Avenue	West	A point 23 metres north of Morrison Avenue and Rogers Road	first day to the 15th day of each month, inclusive, from April 1st to November 30th

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Earlscourt Avenue	East	A point 23 metres north of Morrison Avenue and Rogers Road	16th day to the last day of each month, inclusive, from April 1st to November 30th
Earlscourt Avenue	West	A point 23 metres north of Morrison Avenue and Rogers Road	Anytime, from December 1st of one year to March 31st of the next following year, inclusive
