CITY OF TORONTO

BY-LAW No. 350-2003

To amend By-law No. 3491-80 of the former Borough of York, being a by-law “To provide for night-time parking of motor vehicles on Borough of York highways”.

The Council of the City of Toronto HEREBY ENACTS as follows:

OVERNIGHT ON-STREET PERMIT PARKING

1. That Schedule “A” of former Borough of York By-law No. 3491-80, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

Earlscourt Avenue	West	The southerly City of York limits to Rogers Road	7	12 midnight to 6 a.m. from the 2nd day of each month to the 16th day of each month, April 2nd to December 1st
Earlscourt Avenue	East	The southerly City of York limits to Rogers Road	7	12 midnight to 6 a.m. from the 17th day of each month to the 1st day of each month, April 2nd to December 1st
Earlscourt Avenue	East	The southerly City of York limits to Rogers Road	7	12 midnight to 6 a.m. from the 2nd of December to the 1st day of April

2. That Schedule “A” of former Borough of York By-law No. 3491-80, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:
