**CITY OF TORONTO**

**BY-LAW No. 389-2003**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to  
reflect the name change of Church-Wellesley Business Improvement Area to  
Church-Wellesley Village Business Improvement Area.**

WHEREAS Chapter 19, Business Improvement Areas, of the City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS by the adoption of Clause No. 19 of Report No. 4 of the Economic Development and Parks Committee on May 21, 22 and 23, 2003, City of Toronto Council approved the name change of Church-Wellesley Business Improvement Area to Church-Wellesley Village Business Improvement Area; and

WHEREAS Schedule A of the Toronto Municipal Code, Chapter 19, Business Improvement Areas, must be amended to reflect the name change of Church-Wellesley Business Improvement Area to Church-Wellesley Village Business Improvement Area;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A of the Toronto Municipal Code, Chapter 19, Business Improvement Areas, is hereby amended by changing the name "Church-Wellesley" to "Church-Wellesley Village".
2. The maps of the Church-Wellesley Business Improvement Area in Schedule A of the Toronto Municipal Code Chapter 19, Business Improvement Areas, are hereby replaced with the maps of Church-Wellesley Village Business Improvement Area attached hereto as Schedule A.

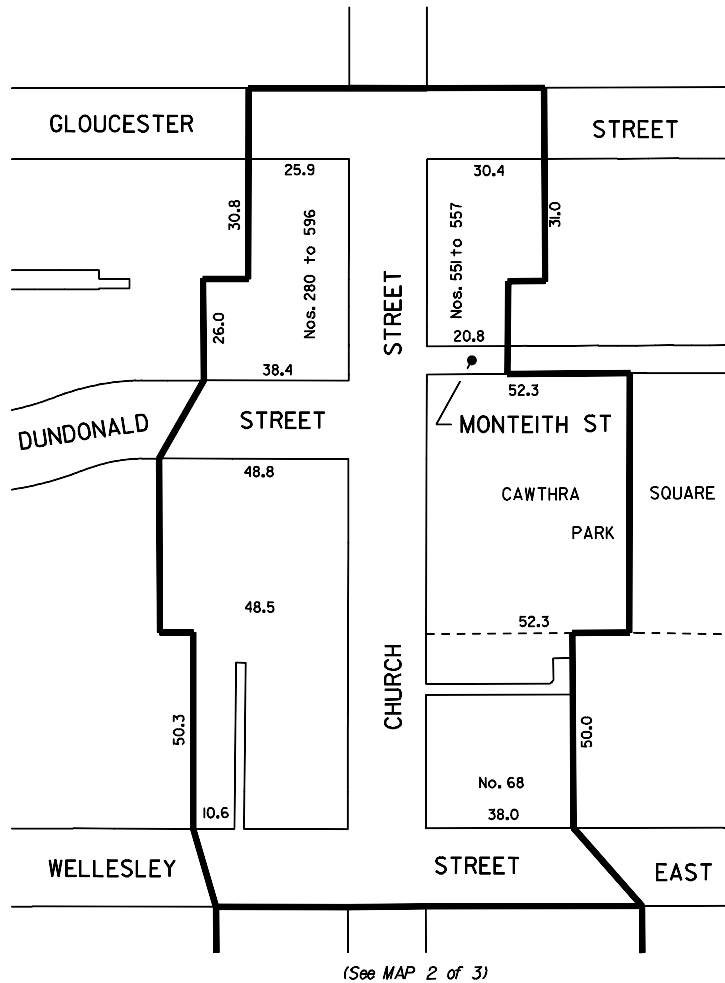

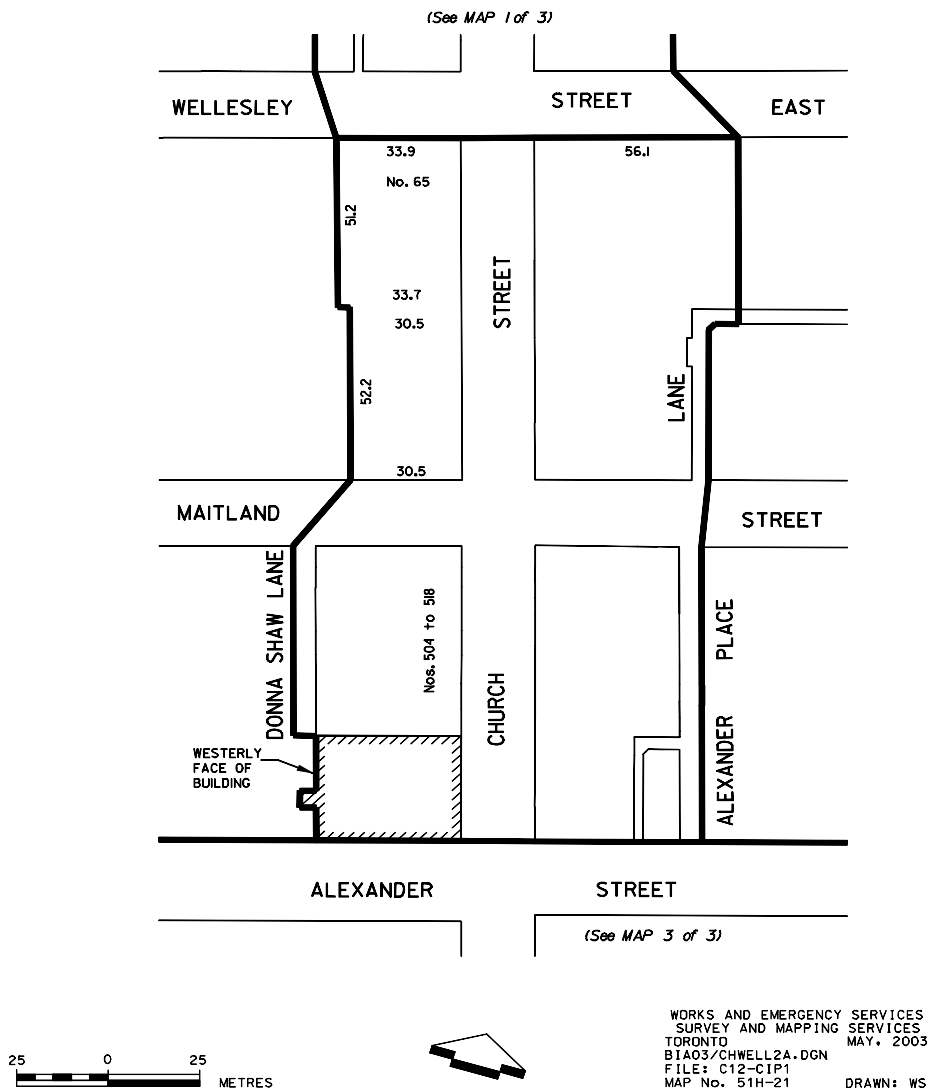
SCHEDULE A

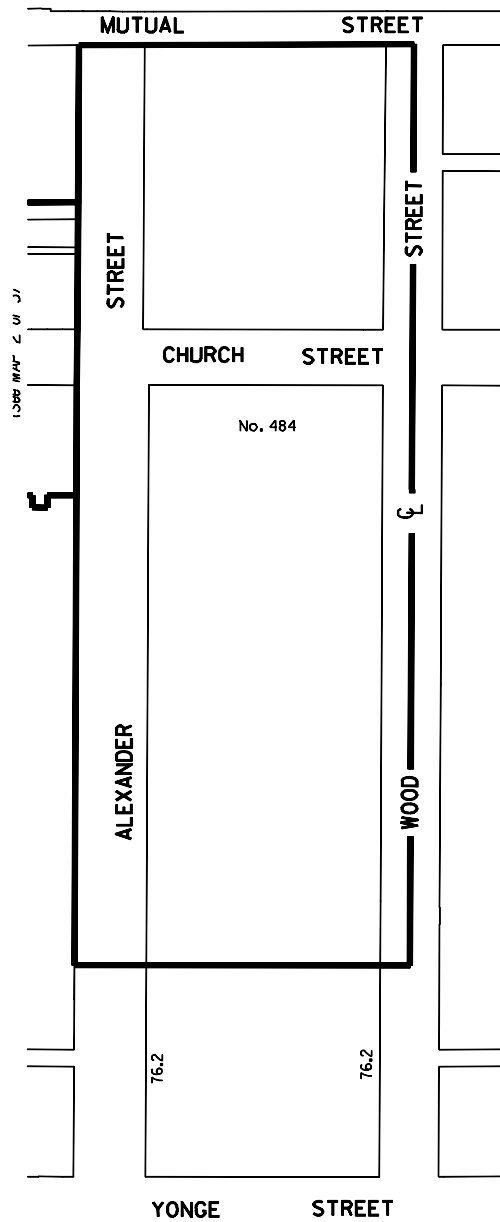
