BY-LAW No. 420-2003

To amend By-law No. 3491-80 of the former Borough of York, being a By-law “To provide for night-time parking of motor vehicles on Borough of York highways”.

The Council of the City of Toronto HEREBY ENACTS as follows:

OVERNIGHT ON-STREET PERMIT PARKING

1. That Schedule “A” of former Borough of York By-law No. 3491-80, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:
