**CITY OF TORONTO**

**BY-LAW No. 430-2003**

**To amend By-law No. 196-84 of the former City of York, being a By-law “To regulate traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**NO PARKING - SCHEDULE VIII**

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Clouston Avenue West	South	Monklands Avenue and Weston Road	Anytime

**NO PARKING - SCHEDULE VIII**

2. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:
