**CITY OF TORONTO**

**BY-LAW No. 445-2003**

**To amend Metropolitan By-law No. 62-91 respecting reserved lanes for bicycles on former  
Metropolitan Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "A" to Metropolitan By-law No. 62-91, being a By-law "To provide reserved lanes for bicycles on certain Metropolitan Roads", as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:
