CITY OF TORONTO

BY-LAW No. 470-2003

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Joseph Duggan Road, Northern Dancer Boulevard, Queen Street East,
Sarah Ashbridge Avenue and Winner's Circle.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By inserting in Schedule XVI (Speed Limits on Highways) in § 400-69, the following in alphabetical order by street name:

- B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
