BY-LAW No. 532-2003

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Abell Street, Armadale Avenue, Lane first north of St. Clair Avenue West,
McRoberts Avenue and Margueretta Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
