**CITY OF TORONTO**

**BY-LAW No. 551-2003**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cumberland Street, Dalhousie Street, Front Street West, McGee Street, Markham Street, Mutual Street, South Drive and Tracy Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
